DHS&EM, FEMA, and other federal agencies are managing the recovery efforts associated with the Cook Inlet M7.1 earthquake at the Joint Field Office (JFO) in Anchorage.

State Wide Wildland Fires

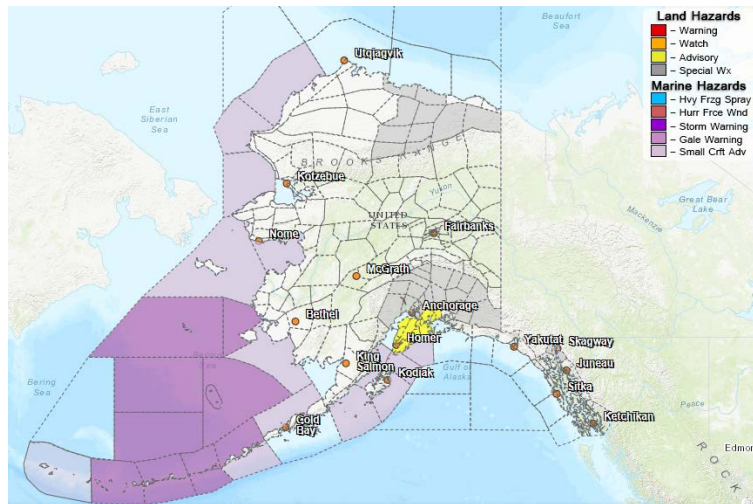
SEOC is monitoring wildland fires statewide. SEOC is in regular contact with local communities that have wildland fires impacting their jurisdictions and is supporting fire incident commands when requested.

Over the weekend, the Fairbanks North Star Borough evacuated the Martin and Perch subdivisions, near Murphy Dome, due to the Shovel Creek fire. The Borough has opened a shelter for evacuees in cooperation with the Red Cross and a pet evacuation shelter. Other subdivisions near the Shovel Creek fire remain under notice to be “set” to evacuate should fire conditions require.

SEOC has deployed Alaska National Guard personnel to the Shovel Creek fire to assist fire personnel and Alaska State Troopers at evacuation checkpoints.

SEOC has deployed a Mobile Emergency Operations Center with personnel to the Boundary River Fire near Northway, and communications equipment to fires in the Fairbanks and Delta Junction area.

A Flood Warning has been issued for the Yentna River at Fish Creek through noon today. Dense Smoke Advisory in effect for the Western Kenai Peninsula and Western Prince William Sound through 1:00 pm Wednesday.
