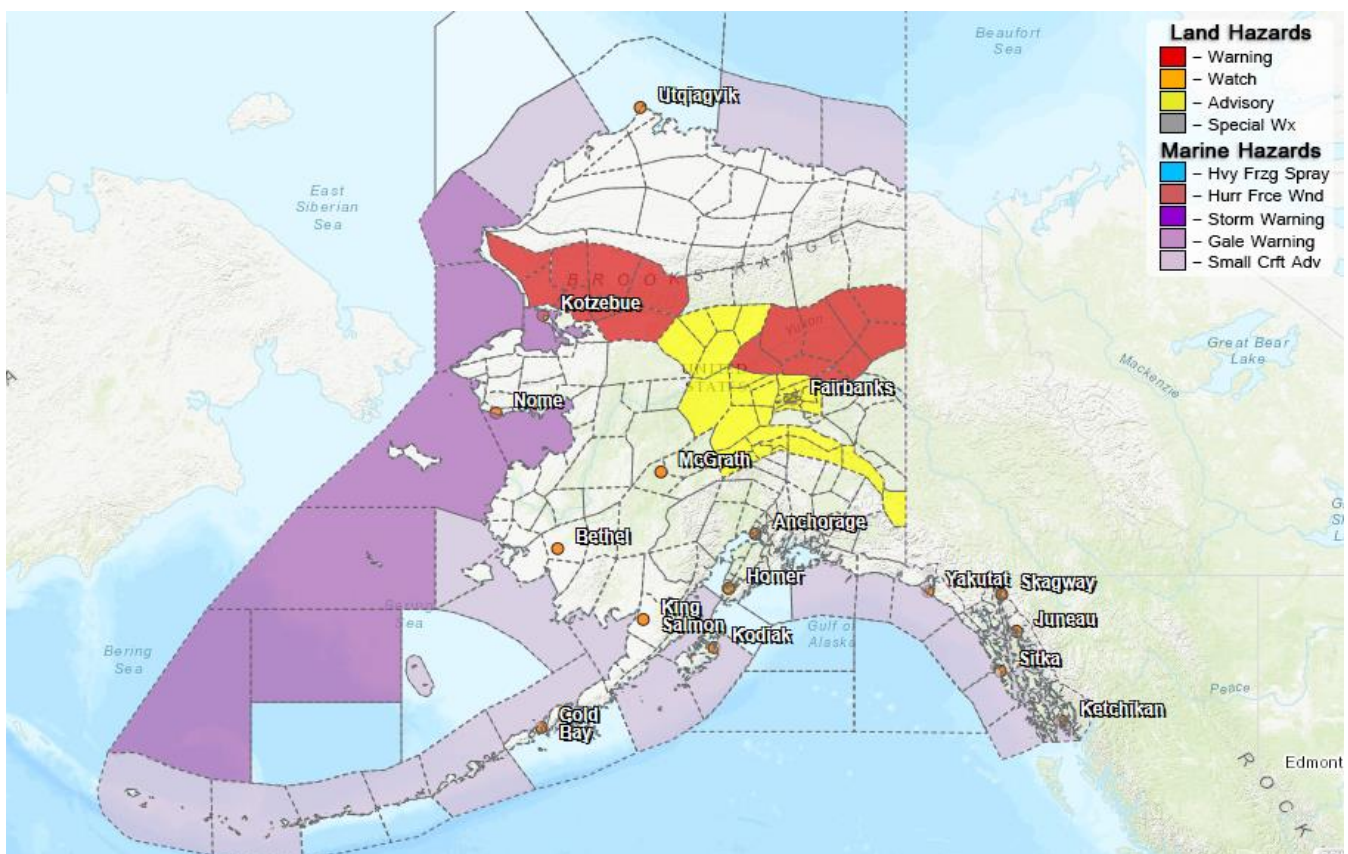

Several Winter Weather Advisories have been issued for the central and eastern Interior, including Denali, Eastern Alaskan Range, Southeastern Brooks Range, Upper Koyukuk Valley, and associated areas, for snowfall into Wednesday morning.

Winter Storm Warnings are in effect for Upper Kobuk and Noatak Valleys, Lower Kobuk, and Yukon Flats, and associated areas. This warning is currently in effect through Wednesday, October 9th, 2019 at 1800hrs.
