Significant Issues

Over the weekend Lake and Peninsula Borough Assembly passed a resolution declaring a local disaster emergency for Newhalen River overflow flooding and requested State disaster assistance. The berms the community put in on Friday are diverting water away from homes. The SEOC continues to work with the community in coordination with the US Army Corps of Engineers.

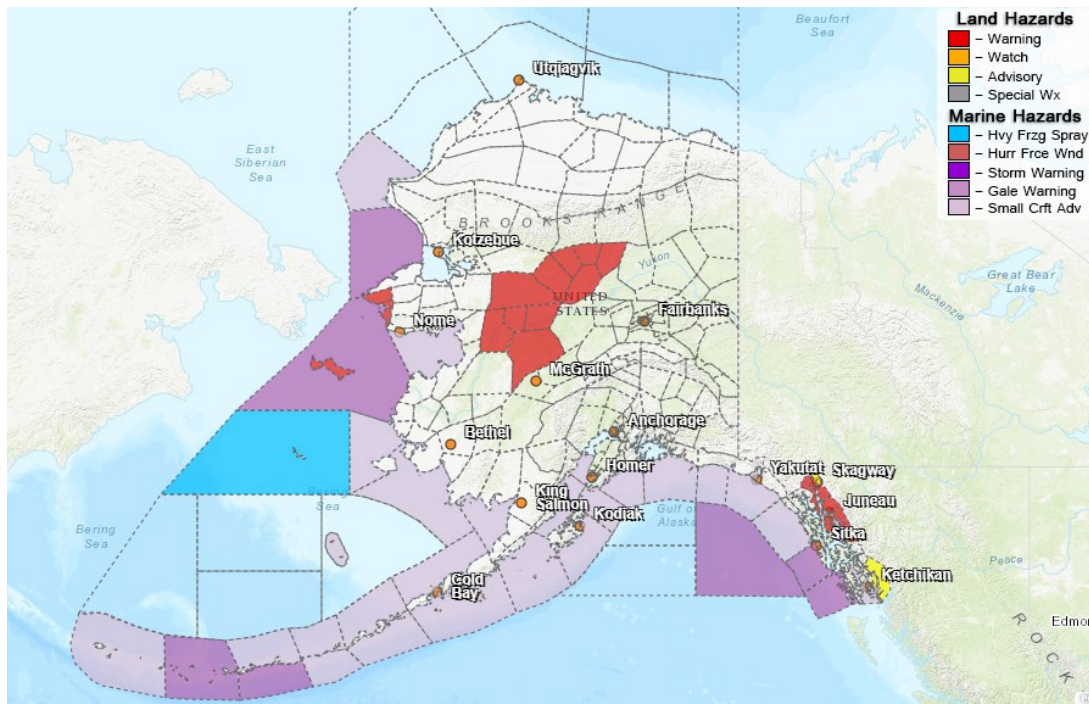
