DHSS is closely monitoring the rapidly-emerging outbreak of novel coronavirus (COVID-19).

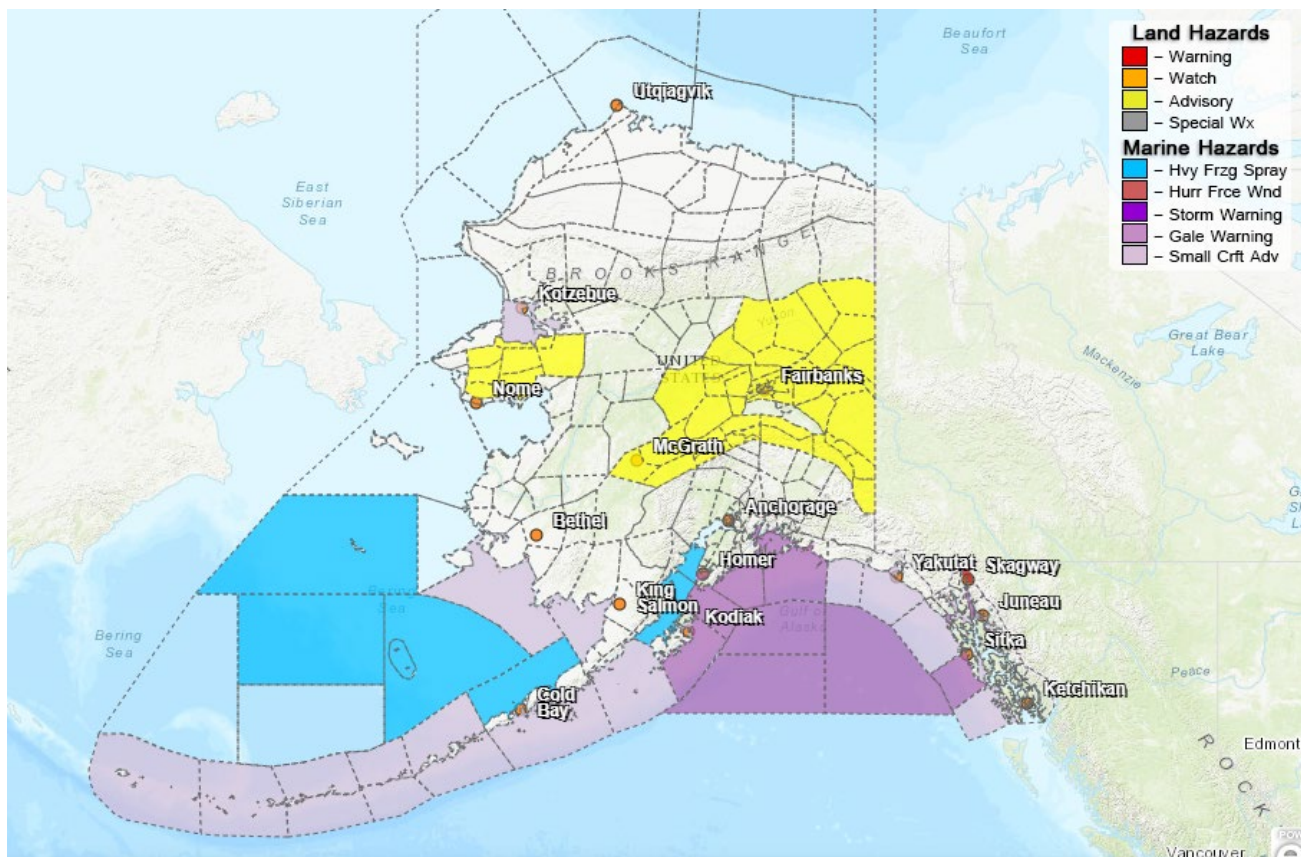

A High Wind Warning is in effect for the Taiya Inlet and Klondike Highway until this afternoon.

A Winter Weather Advisory for snow is in effect for much of the central and eastern Interior and Alaska Range for today and into tomorrow morning in some locations.

A Wind Chill Advisory is in effect for the Northern and Interior Seward Peninsula until noon today.

A Winter Weather Advisory is in effect for the Upper Kuskokwim Valley until noon today.

Avalanche Hazards

Cordova: Avalanche Hazard is Considerable above 2,000 feet, and Moderate between 1,000 and 2,000 feet.

Valdez: Avalanche Hazard is Considerable above 1,500 feet and Moderate below 1,500 feet.

Turnagain Pass: Avalanche Hazard is Moderate at all elevations.
