A unified command has been established at the SEOC. The SEOC Preparedness Level remains at Level 3 for this event.

#### **2020 Fire Season**

The Alaska Interagency Coordination Center, (AICC) is at Preparedness Level 1.

Total Fires = 88

Total Acres = 238

There are currently 18 active fires with 0 fires currently staffed.

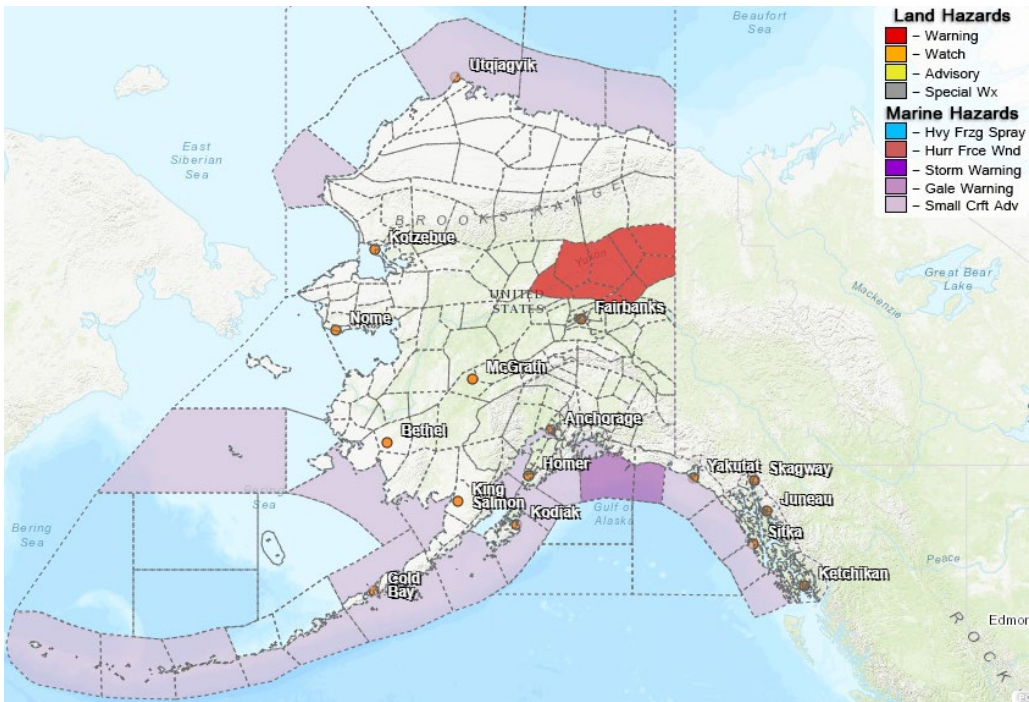

### **Significant Weather:**

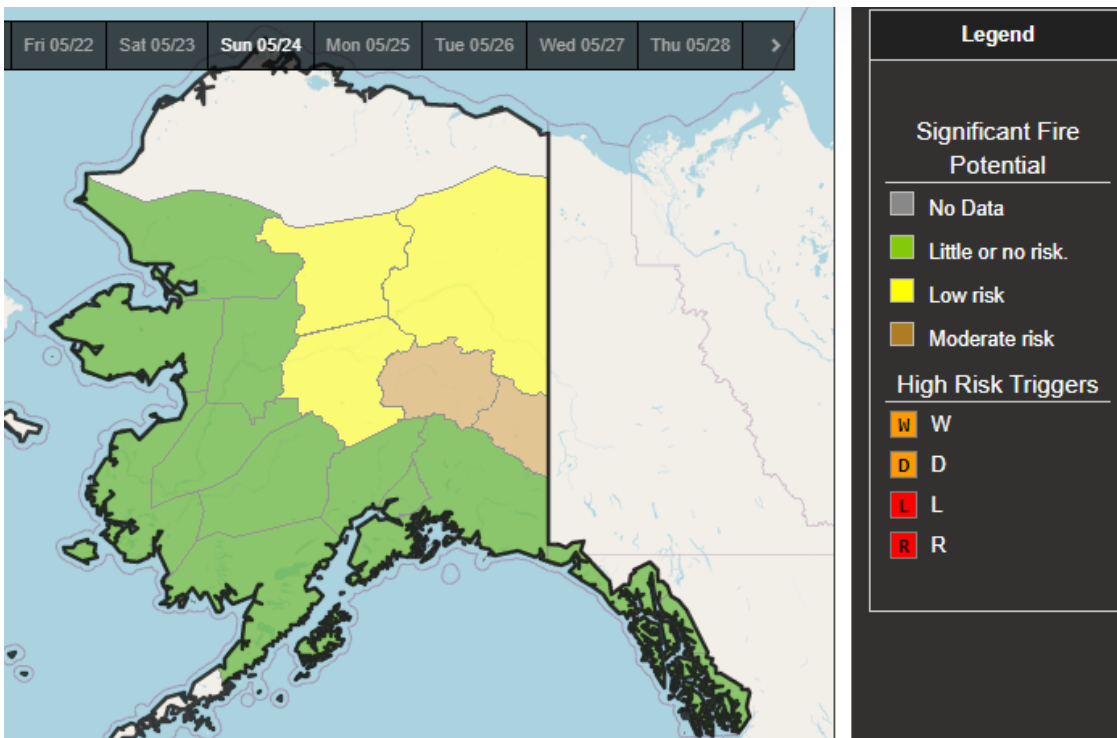


Red flag warning is in effect from noon today to 10 pm this evening for the Yukon Flats north and east of Fort Yukon.
