Coronavirus (COVID-19) Pandemic

A unified command has been established at the SEOC. The SEOC Preparedness Level remains at Level 3 for this event.

2020 Fire Season

The Alaska Interagency Coordination Center, (AICC) is at Preparedness Level 3.

Wildland fire totals for 2020:

Total Fires = 252

Total Acres = 158,773.5

There are currently 116 active fires with 9 fires currently staffed.

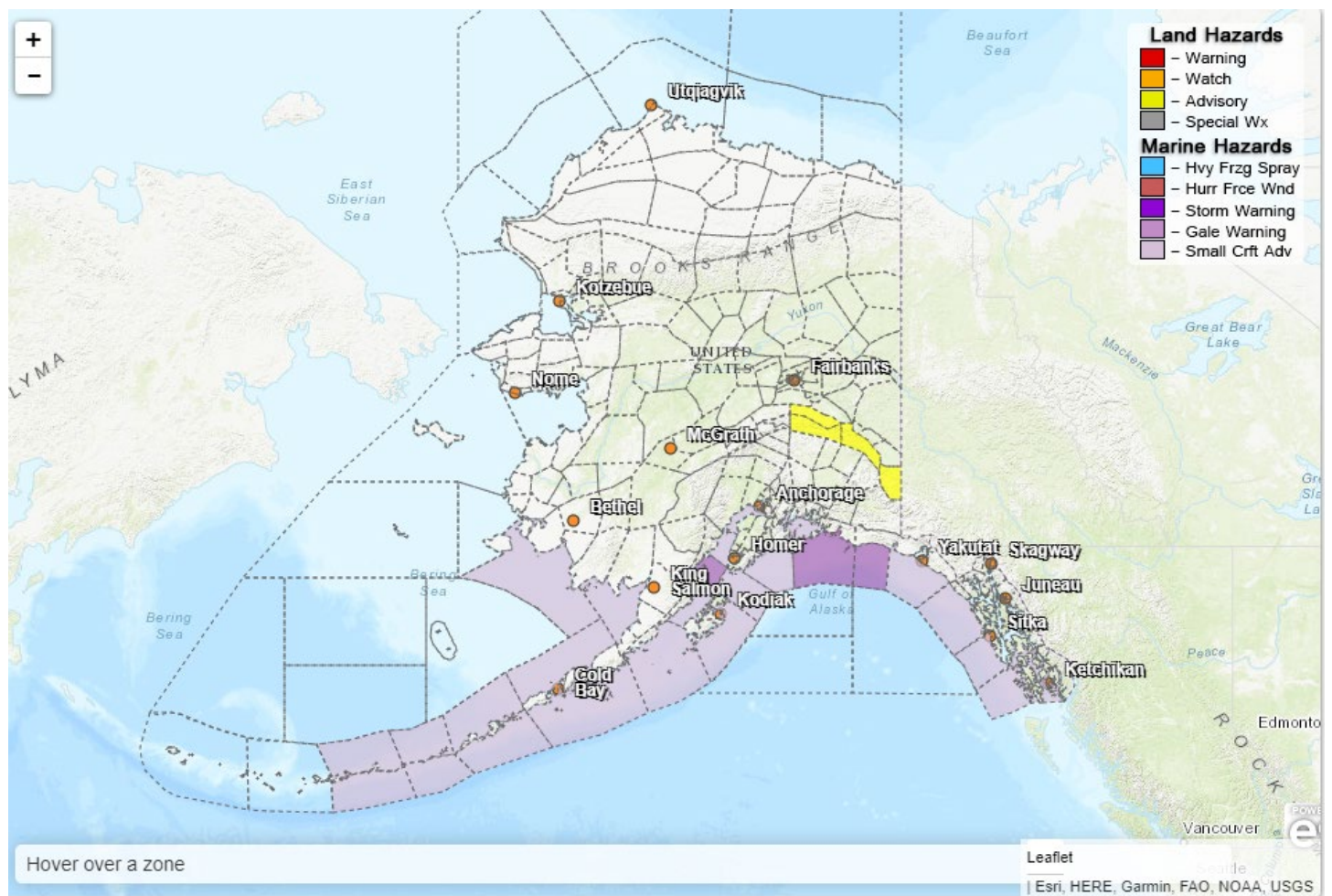

Significant Weather:

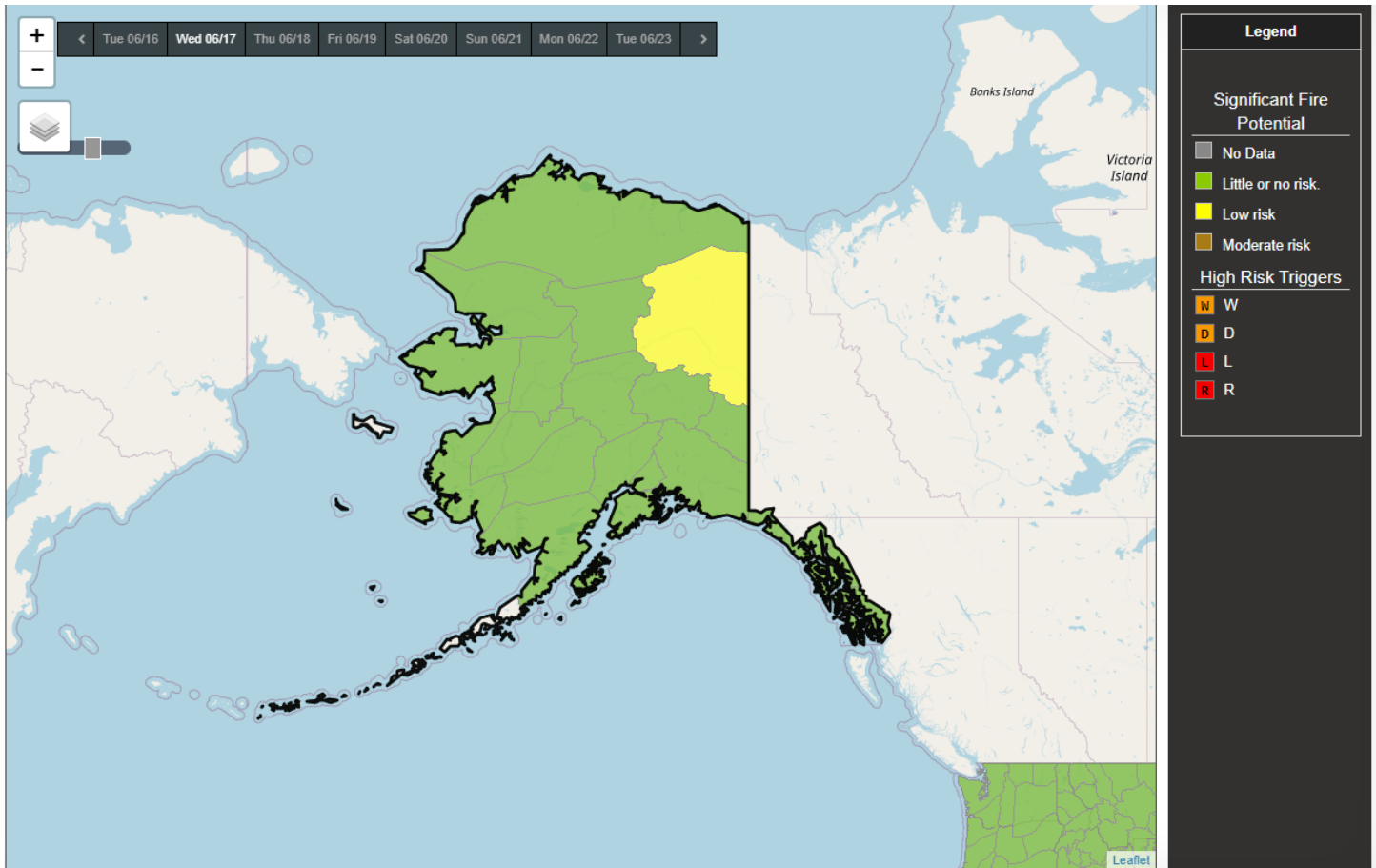


A wind advisory is in effect for the eastern Alaska Range from Donnelly Dome north until 10 pm tonight.
