A unified command has been established at the SEOC. The SEOC Preparedness Level remains at Level 3 for this event.

**2020 Fire Season**

The Alaska Interagency Coordination Center, (AICC) is at Preparedness Level 2.

Total Fires = 278  
Total Acres = 170,882

There are currently 99 active fires with 1 fire currently staffed.

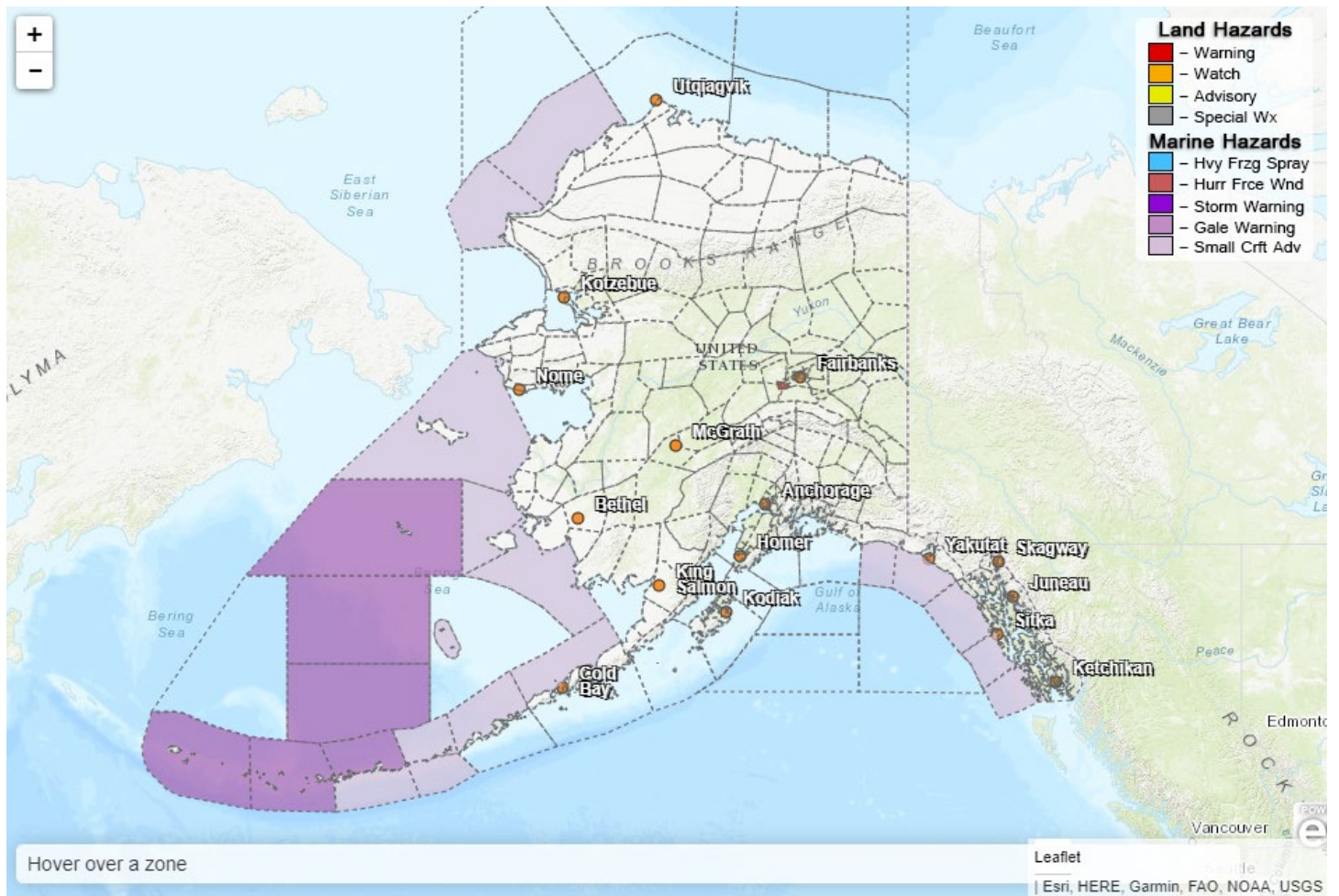

## Significant Weather:

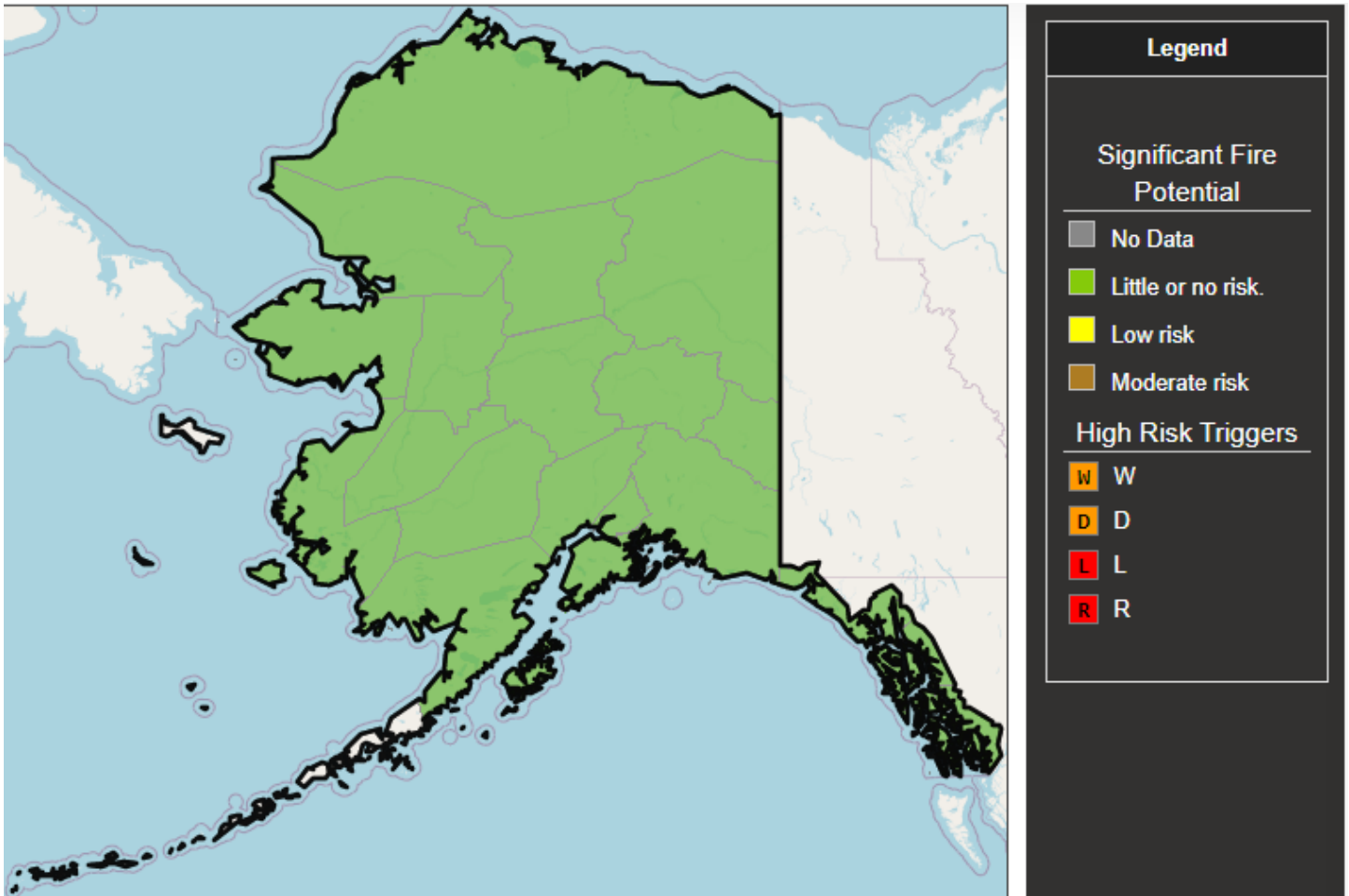
