**Coronavirus (COVID-19) Pandemic**

A unified command has been established at the SEOC. The SEOC Preparedness Level remains at Level 3 for this event.

**2020 Fire Season**

The Alaska Interagency Coordination Center, (AICC) is at Preparedness Level 1.

Wildland fire totals for 2020:

Total Fires = 309

Total Acres = 177,229

There are currently 68 active fires with 4 fires currently staffed.

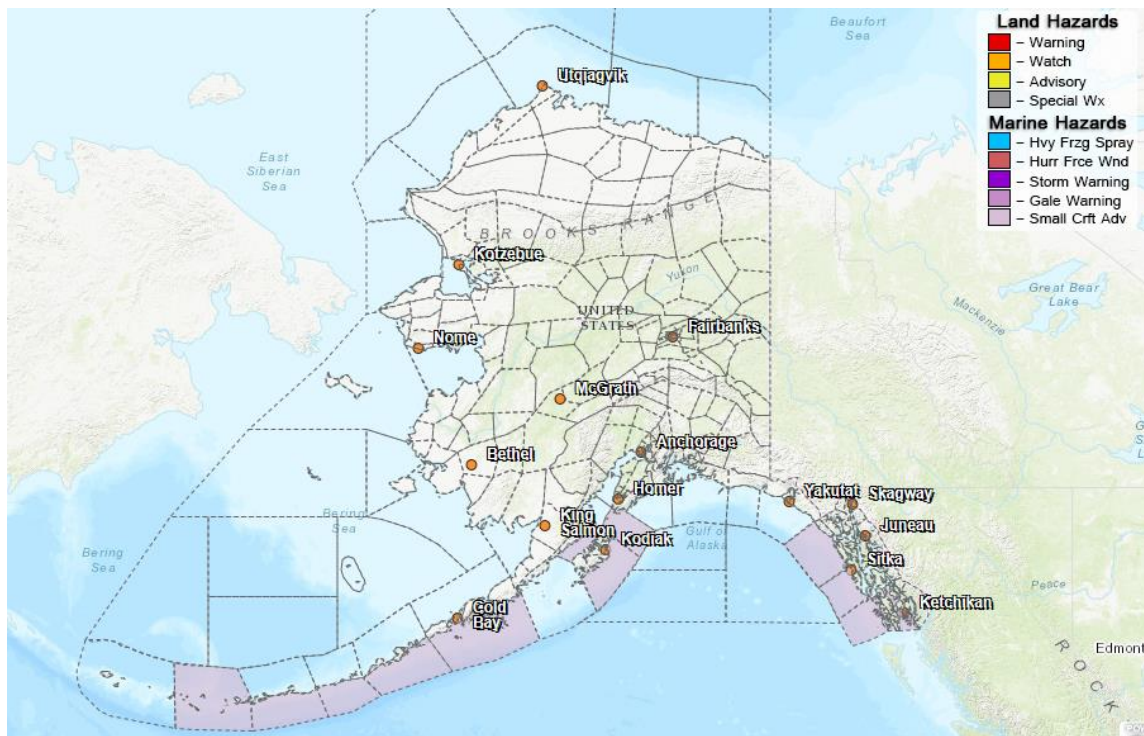

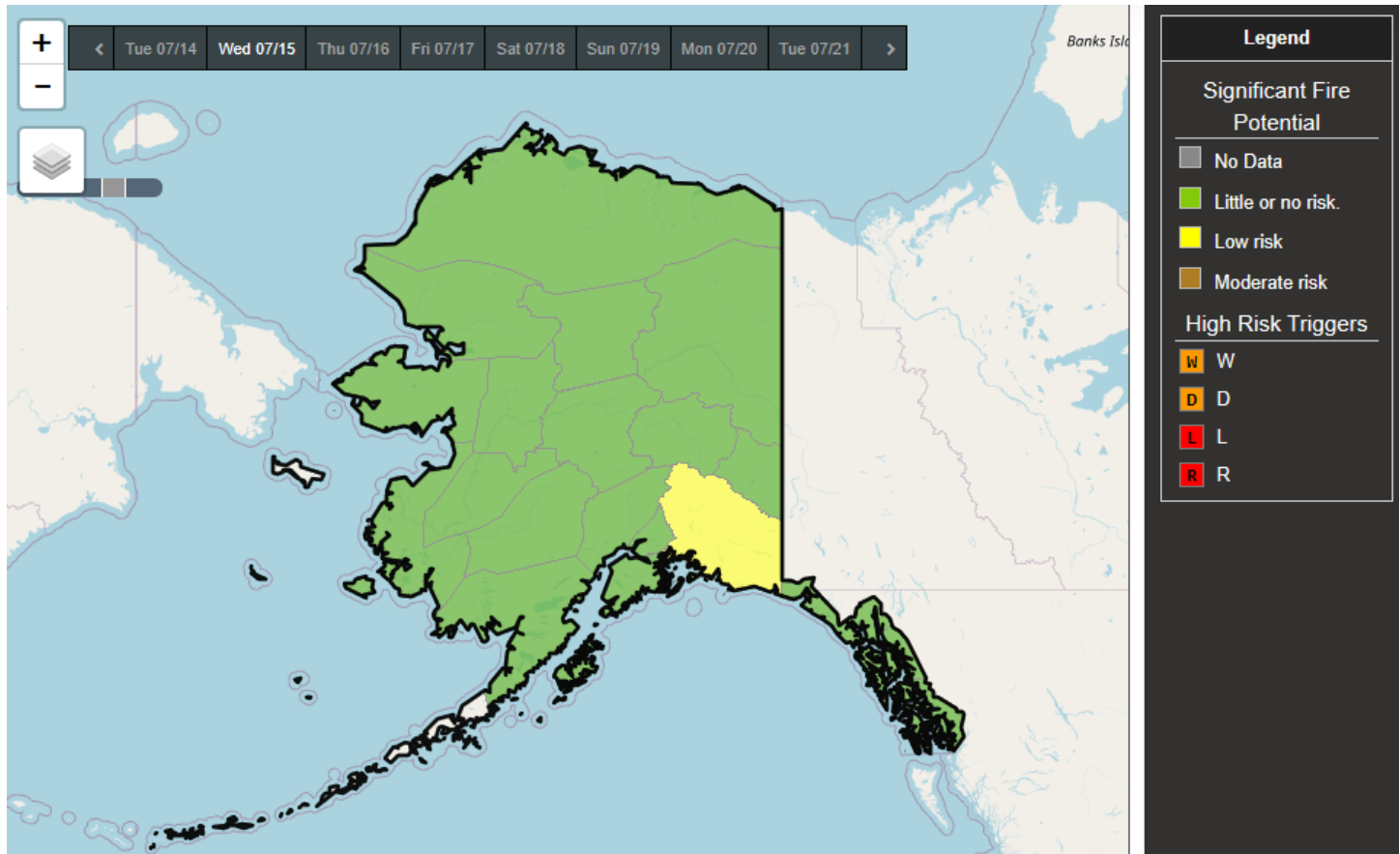
## **Significant Weather:**
