A unified command has been established at the SEOC. The SEOC Preparedness Level remains at Level 3 for this event.

2020 Fire Season

The Alaska Interagency Coordination Center, (AICC) is at Preparedness Level 1.

Wildland fire totals for 2020:

Total Fires = 331

Total Acres = 181,211

There are currently 24 active fires with 1 fire currently staffed.

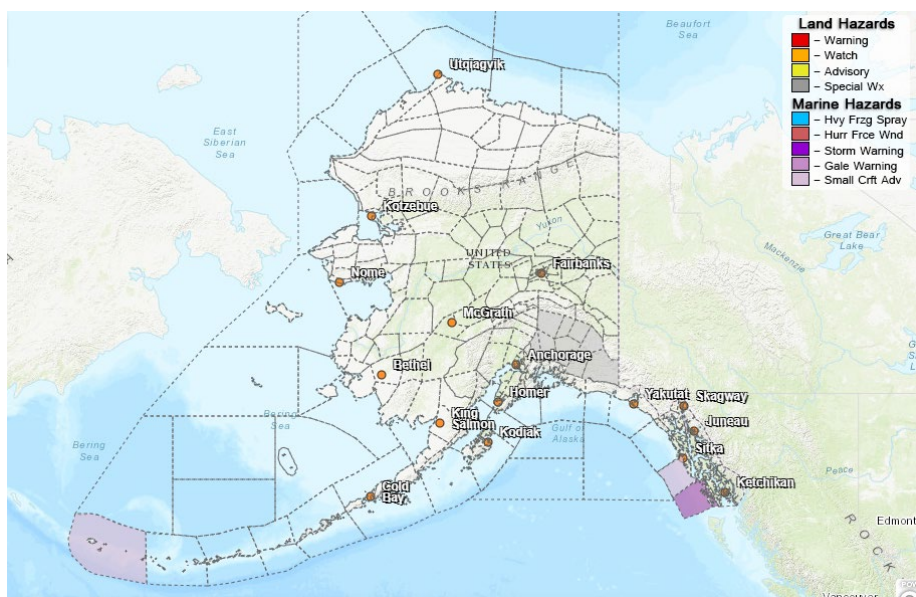
