Total Acres = 181,212

There are currently **20** active fires with 0 fires currently staffed.

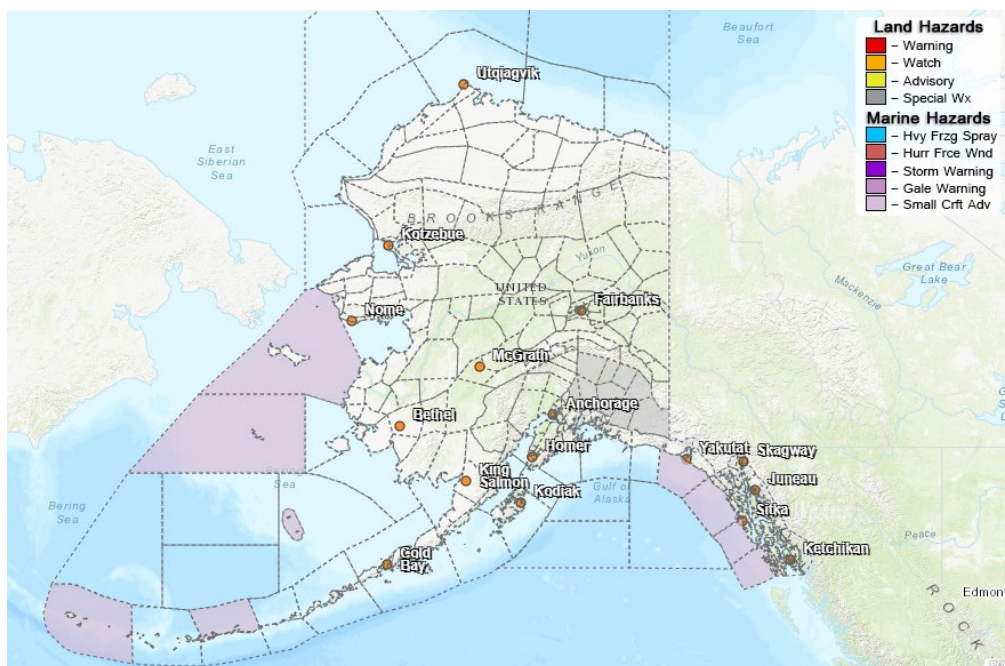
