**Significant Issues:**

**Tsunami Warning Test Error**

At approximately 0842 AST on Thursday June 2, 2022, during routine monthly testing of the national tsunami warning system, the National Weather Forecast Office in Anchorage inadvertently transmitted the test to eight NOAA Weather Radio towers, which automatically triggered tsunami sirens in areas of the Kenai Peninsula Borough and activated some Emergency Alert Systems that were monitoring NOAA Weather Radio as a source. The National Weather Service is taking steps to prevent this from happening again.

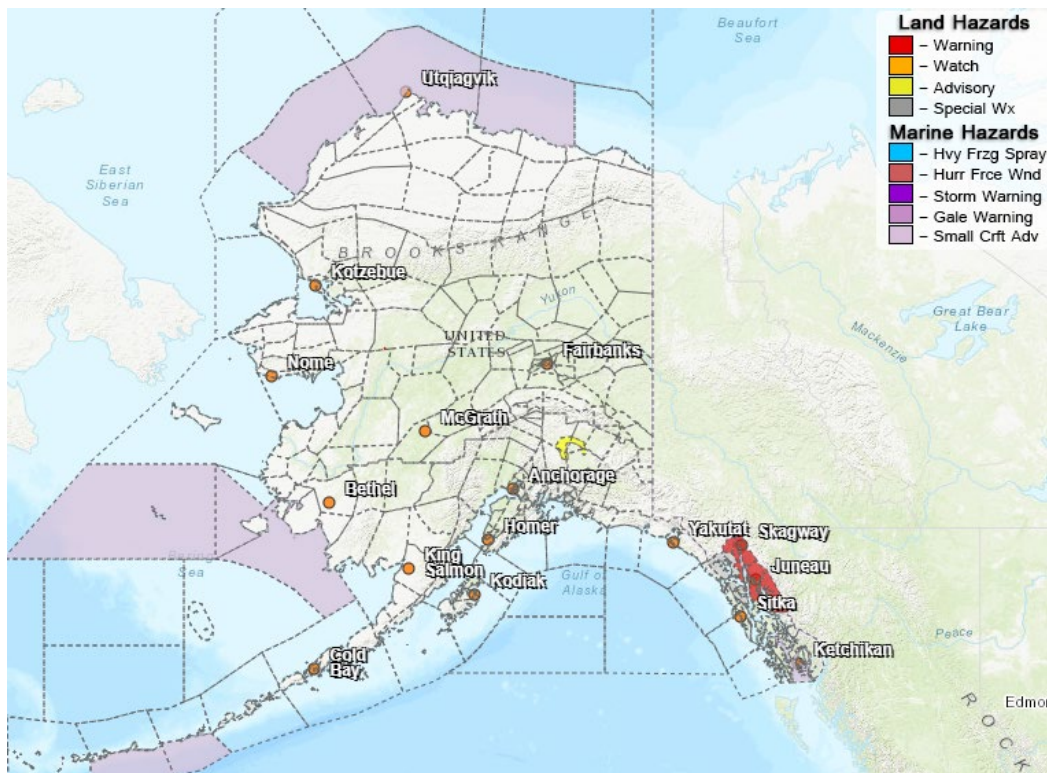
