Significant Issues:

Statewide Fires

Thanks to ongoing fire suppression efforts and favorable weather, the Denali Borough scaled back evacuation levels to READY and SET on the Clear Fire. There are no longer any GO! Levels. The Tri Valley School and Nenana Schools have been closed for evacuation levels.

Due to reduced fire activity and cooler, wet weather patterns, the BLM rescinded two fire protection orders for BLM-managed public lands in eastern and central Alaska. There is still a fire protection order in effect for the Fairbanks area.

With continued moderation of fire weather and demobilization of resources including crews and aircraft, the Alaska Multi-Agency Coordinating Group downgraded the Preparedness Level to 3 of 5.

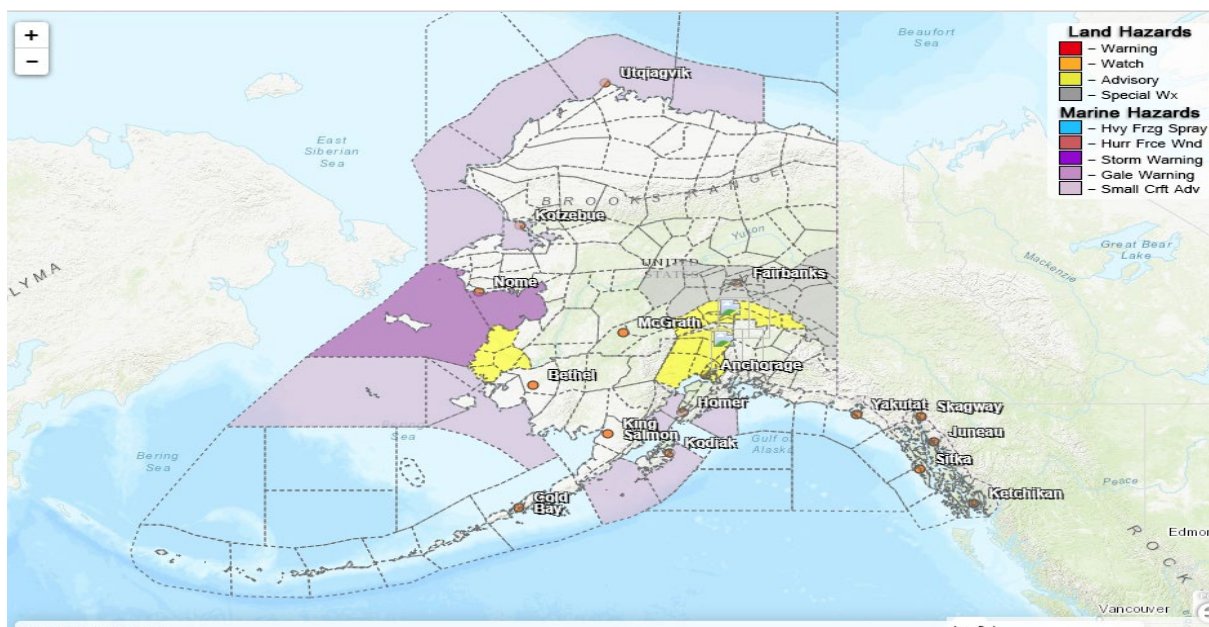

Significant Weather:



Special Weather Statements have been issued for the following areas:

- Denali – Eastern Alaska Range for increased risk of flooding, rockslides, and landslides due to excessive rainfall.
- Denali - Eastern Alaska Range for excessive wind with gusts up to 50 mph in effect through 4:00am Friday
- Mat-Su Valley for flooding due to excessive rainfall in effect through Saturday at 4:00am
- Anchorage Bowl streams and rivers including Chester and Campbell Creeks for potential flooding due to excessive rain fall.
- Yukon Delta for high surf advisory – Kotlik to Hooper Bay Sea levels 2-3 feet above normal tides expected in effect through tonight.
