Cook Inlet Earthquake

The SEOC continues to be activated to Level 3 in response to the M7.0 earthquake affecting the Municipality of Anchorage, Matanuska-Susitna Borough, and Kenai Peninsula Borough. The State has activated the State Individual Assistance Program for earthquake survivors. 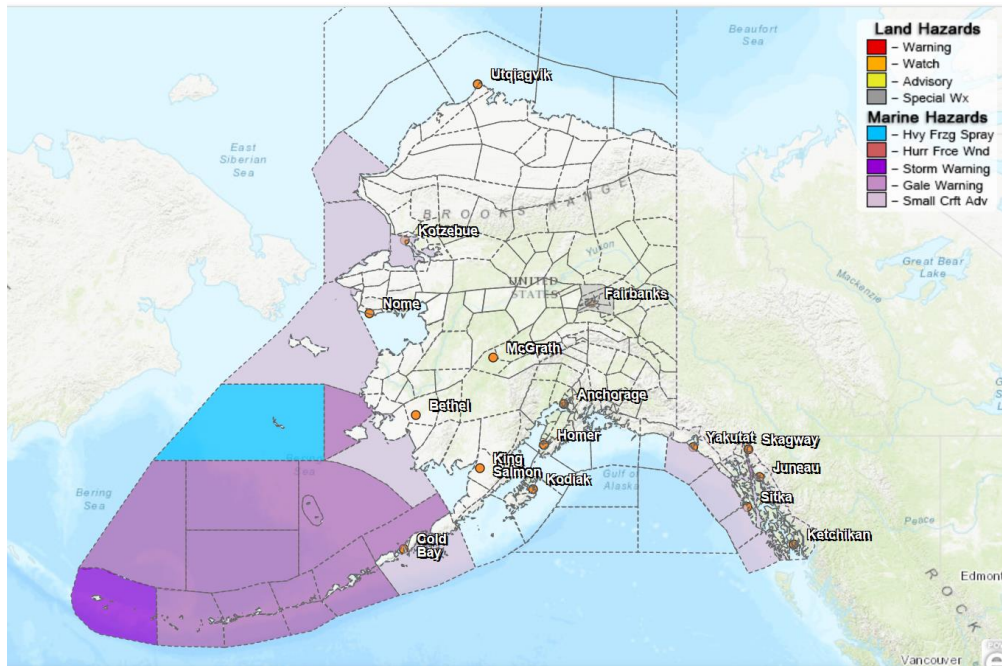
Thorne Bay Landslide

The SEOC spoke this afternoon with the USFS geologist who visited the slide site. He is preparing a detailed report for the USFS District Ranger and will send us a copy tomorrow. The slide is about 200' wide and has likely destroyed approximately 100' of road and road prism. The Alaska Power and Telephone (APT) lost about 13 power poles and power has been disrupted to South Thorne Bay. APT should be able to install a couple poles on either side of the slide and restore power to the South Thorne Bay area. The City of Thorne Bay and Kasaan are each planning to clear the debris on their ends of the slide. At present, road access is unavailable to emergency vehicles. The SEOC is maintaining communication with the City of Thorne Bay and Kasaan as well as the USFS District Ranger.
