Cook Inlet Earthquake

The SEOC continues to be activated to Level 3 in response to the M7.0 earthquake affecting the Municipality of Anchorage, Matanuska-Susitna Borough, and Kenai Peninsula Borough. The State has activated the State Individual Assistance Program for earthquake survivors. 
Diomede Power Issues

AEA reports that as of this morning, the Diomede Joint Utilities (DJU) is suppling power to its customers, with the exception that three homes and one commercial building remain without power. AEA could not confirm the homes or commercial building are occupied. DJU is still hoping to get a repairman out to the island soon to perform necessary maintenance and other repairs to the powerhouse and distribution system. DJU has had at least 9 significant outages since September 2016. AEA and the SEOC are each closely monitoring the power situation in Diomede.
