

#### **DHS&EM OPERATIONS**

Cook Inlet M7.1 Earthquake (FEMA Declaration 4413-DR)

This is the 124<sup>nd</sup> day since the earthquake. FEMA command and general staff will began working out of a temporary Joint Field Office (JFO) set up at the FEMA Anchorage Office located at the Anchorage Federal Building Annex. FEMA has 247 persons and four Disaster Recovery Centers working in Alaska on this disaster. To date, FEMA has dispensed over \$7.8 million in Individual and Households Program funds and almost \$7.6 million in Housing Assistance funds. SBA has approved 771 home loans and 36 business loans totaling over \$37.3 million.


#### **Diomede Power Issues**

The SEOC received a call from AEA this morning that Diomede had a limited power outage. Their Circuit Rider Technician reports there is a broken line on the system causing six residents to be out of power. A repairman with experience working on the Diomede power system is trying to get to the island to assist.
