


Diomede Water System Freeze up

The SEOC continues to monitor the developing water disruption in Diomede. The only water treatment plant (WTP) operator is leaving the community permanently on Monday. The operator states the sample tap inside the water plant was now frozen, and likely also the water tank, exterior water piping, and interior piping in the water plant. Two Remote Maintenance Workers (RMWs) from Norton Sound Health Corporation (NSHC) were scheduled on the helicopter to Diomede Tuesday, but mechanical issues caused that flight to be delayed a week or more. Once the RMWs are on the ground, they'll provide technical assistance. If fully frozen, waiting a few weeks for temperatures to warm above freezing is likely the best solution, followed by a damage assessment. Without a local operator and consistent maintenance, however, this problem will not be resolved long term. The Alaska Native Tribal Health Consortium continues to work with NSHC, the Diomede mayor, and others to determine how best to help the community.

RiverWatch 2019: Breakup of the state's major rivers continues. There are now some open stretches of the lower Tanana River. The weather appears to be cooling statewide. The NWS Climate Prediction Center models show a cooler and wetter forecast for the next 6-10 days that will likely slow down the melt process and delay breakup a bit. The Upper Yukon and Upper Kuskokwim field teams should deploy sometime next week.
