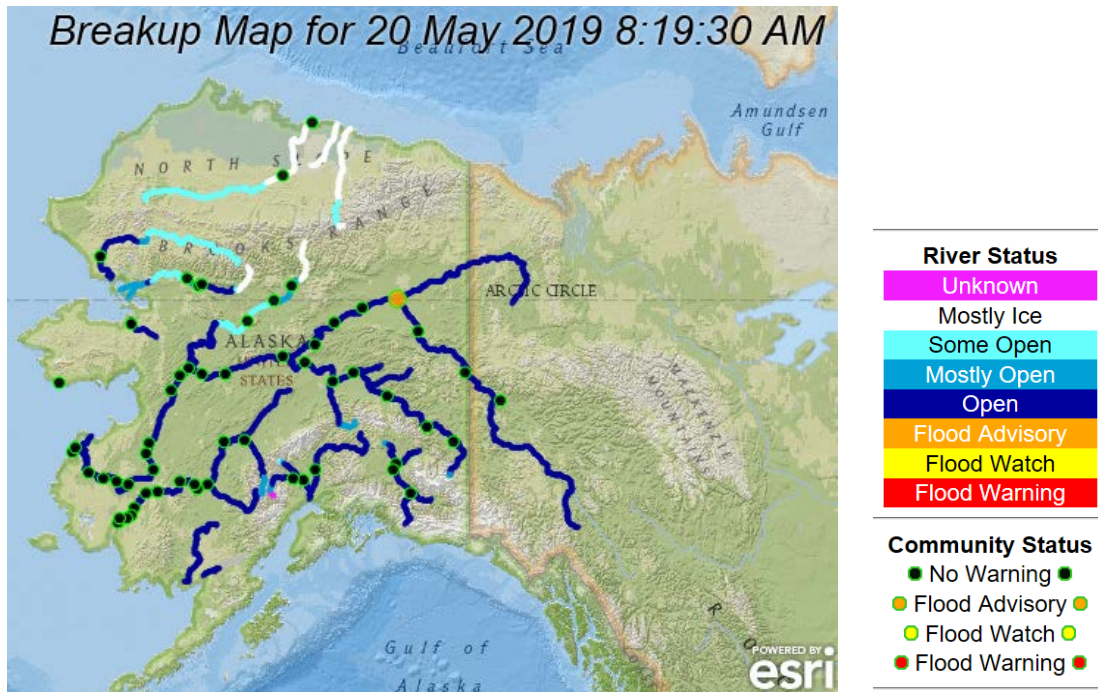
**Cook Inlet M7.1 Earthquake (FEMA Declaration 4413-DR)**

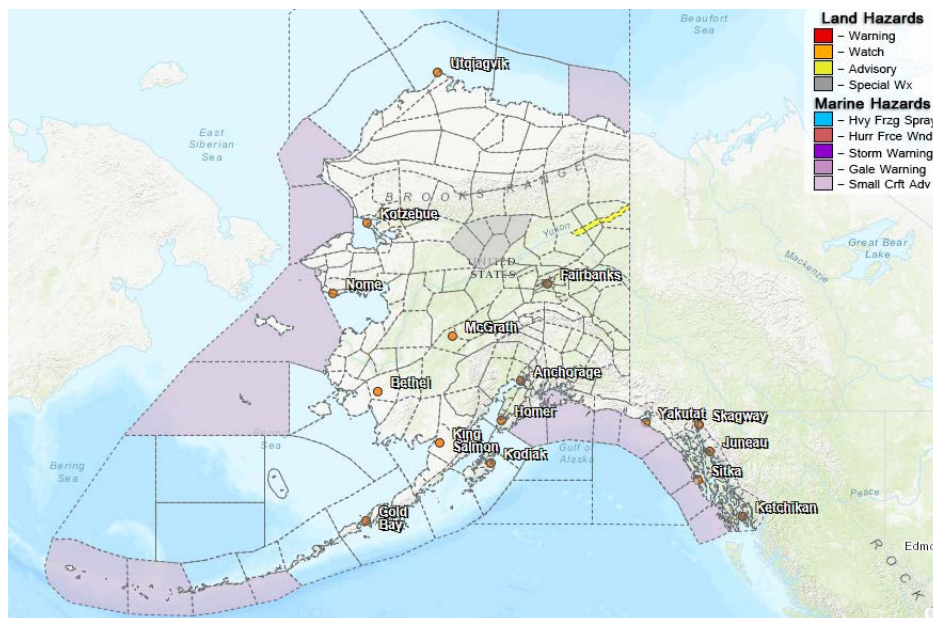
## River Watch 2019



There is a Flood Advisory for the Yukon Flats and Surrounding Uplands through May 21, 2019 09:15 AKDT. no flooding has occurred at Fort Yukon. However, rapid water rises could occur as water moves downstream from the Porcupine River. Expected impacts: Water levels will be bank full or higher and heavy ice runs can be expected over the next several days. As snowmelt crests the water levels will fall slowly back below minor flood stage. Residents living near the Porcupine River should prepare for high water and ice runs and potential minor flooding. NWS and the SEOC will continue to monitor the river conditions.
