THREAT LEVEL CHANGES: LEVEL 2 – HEIGHTENED AWARENESS

Kobe Wildfire near Anderson

Evacuation levels were lowered for the Kobe AG and Anderson subdivisions from a ‘Level 2: Set’ to a “Level 1: Ready” notice on Saturday and the “Level 1: Ready” evacuation notice for the town of Anderson was lifted.

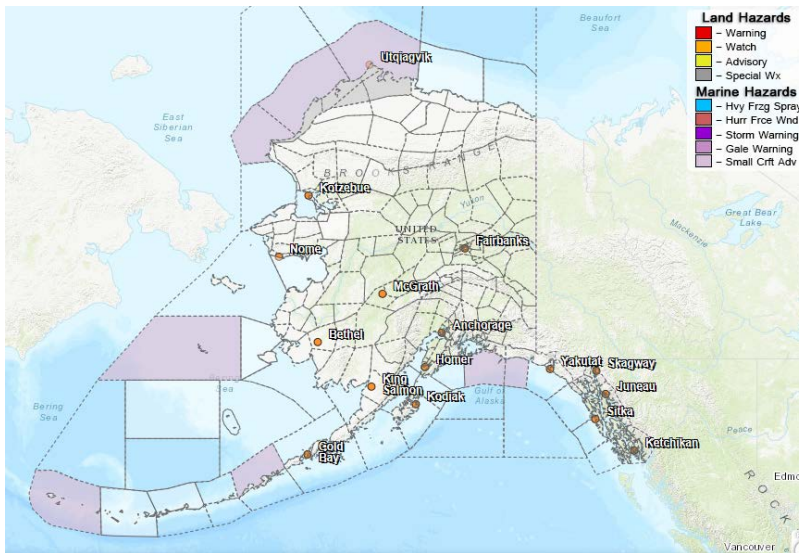
Frozen Calf Fire (Part of Chalkyitsik Complex Fire)

A Type II Incident Management Team is on scene to handle the fire. Acreage for this fire is at 135,370 via imagery. The SEOC is monitoring this situation closely and has contacted both TCC and DHSS to discuss what measures may be taken should the fire threaten the village of Chalkyitsik.

Statewide Fires:

The SEOC remains activated at Level 2 – Heightened Awareness, due to the statewide wildfire situation. **Precipitation, higher humidity and lower temperatures have reduced fire activity in much of the state over the weekend.** The SEOC continues to coordinate deployments of AKNG helicopters and personnel, mobile communication equipment, and the Mobile Emergency Operations Center in support of Alaska Division of Forestry and local communities.
