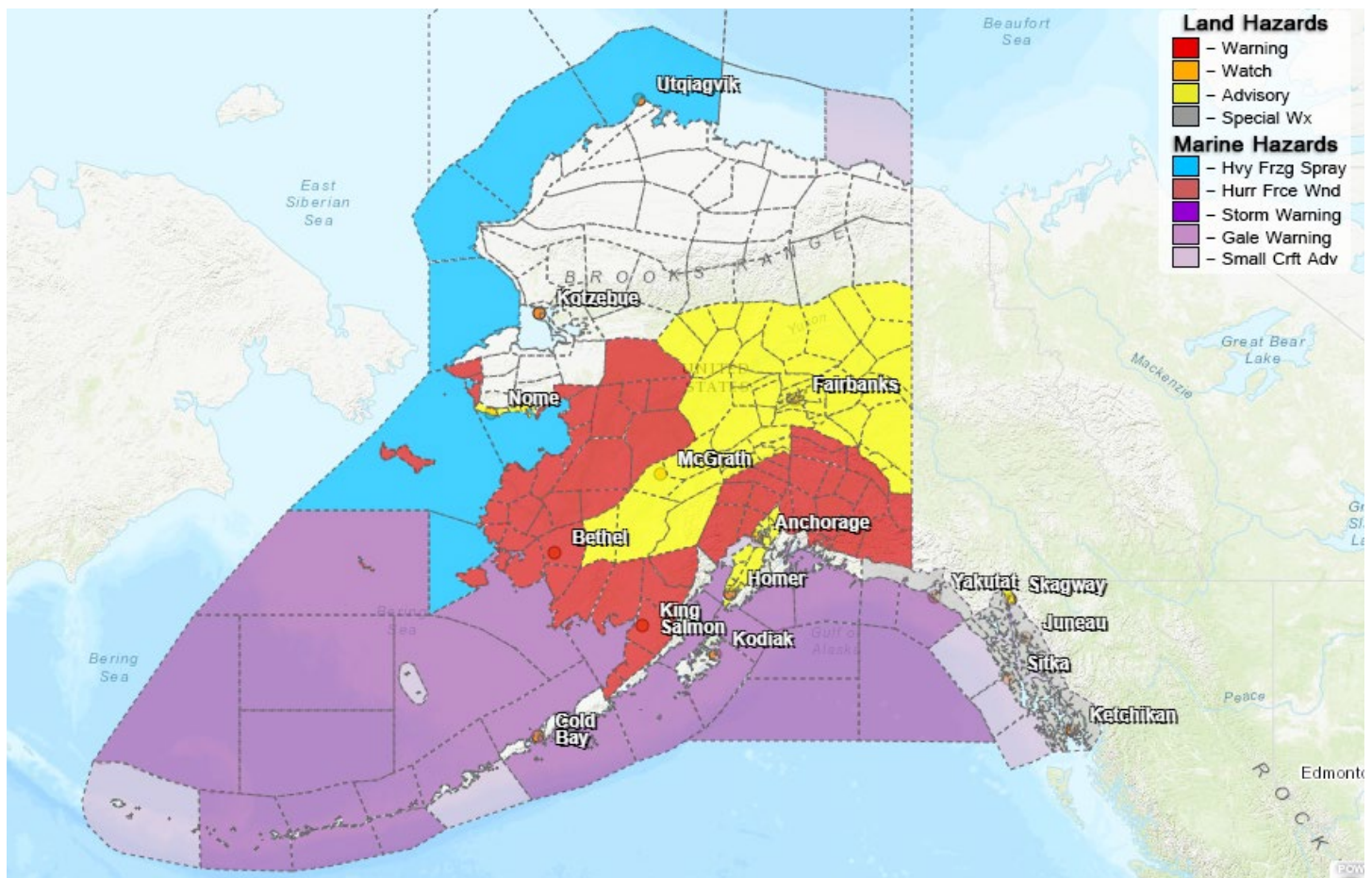

Significant Weather:



Winter storm warnings in effect until Wednesday morning for the Yukon Delta, Yukon Valley, Eastern Norton Sound, Lower Koyukuk, Upper and Lower Kuskokwim Valley areas for heavy mixed precipitation, snow accumulations up to 6 inches.

Blizzard Warning in effect until this afternoon for the Kuskokwim Delta for snow accumulation up to 12 inches with blowing winds of 35-45 mph.

High wind warning and High Surf Advisory in effect until Wednesday afternoon for St. Lawrence Island and the Bering Strait Coast for winds of 30-50 mph with gusts up to 65 mph.

High wind watches and winter weather advisories in effect until Wednesday afternoon for the Deltana and Tanana Flats, Denali, Eastern Alaska Range, and the Central Interior. Winds of 35-45 mph with gusts up to 70 mph are possible with snow accumulation of 4-7 inches expected.

Winter Storm Warnings and Winter Weather Advisories in effect for much of Southcentral Alaska through tomorrow morning for heavy snow and/or freezing rain.

A Special Weather Statement and a Hydrologic Outlook statement have been issued for Southeast Alaska for heavy rain expected from today through Friday.
