### **Significant Issues:**

The SEOC is monitoring a storm related power outage in Diomede. The SEOC has been in contact with the community, assisting agencies and the local government specialist. Repairs are expected as soon as Sunday afternoon. No injuries or other reports of damage were reported and there are no requests for additional State assistance at this time. SEOC will continue to monitor the situation and maintain regular contact with the community.

#### Air Quality Index (AQI) Advisories


An Air Quality Advisory is in effect for the North Pole Zone. All solid fuel-fired devices must cease operation unless the exceptions above apply. Residents should rely instead on their home's cleaner source of heat (such as a gas or fuel oil fired furnace or boiler or electric baseboard heaters) until the Stage 1 alert is canceled. This does not apply during a power outage.

#### Significant Weather:



A special weather statement has been issued for the Western Prince William Sound. Snow on Wednesday turning to a wintery mix by Thursday. Snow is expected to develop on Wednesday morning over the eastern Kenai Peninsula and become heavier by afternoon. Warmer air moving into the region will start to turn the snow to rain in Seward and Turnagain Arm Wednesday night and continue as rain into Thursday in those locations.

A special weather statement has been issued for the Susitna Valley. A storm system will likely bring heavy snow to the Susitna Valley beginning Wednesday afternoon or evening and continuing through Thursday.

A winter storm warning is in effect for Northeastern Brooks Range, Northwestern Brooks Range, Western Arctic Coast, Central Interior, Upper Koyukuk Valley, Southeastern Brooks Range, Lower Kobuk and Noatak Valleys, Chukchi Sea Coast, Upper Kobuk and Noatak Valleys, Lower Koyukuk and Middle Yukon Valleys, Lower Yukon Valley, Yukon Delta, St. Lawrence Island and Bering Strait Coast, Eastern Norton Sound and Nulato Hills, Southern Seward Peninsula Coast, Northern and Interior Seward Peninsula, and the Baldwin Peninsula and Selawik Valley.

A winter weather advisory is in effect for the Upper Kuskokwim Valley and the Northern Arctic Coast.

A winter storm watch is in effect for the Lower Kuskokwim Valley.

A high wind warning is in effect for Denali and Eastern Alaska Range.

A high surf advisory is in effect through Wednesday afternoon for the St. Lawrence Island and Bering Strait Coast.

A wind advisory is in effect for Deltana and Tanana Flats.

A coastal flood warning is in effect through Wednesday afternoon for the Chukchi Sea Coast, Southern Seward Peninsula Coast, the Yukon Delta, Northern Arctic Coast, Eastern Norton Sound and Nulato Hills.

A coastal flood advisory is in effect through Tuesday afternoon for the Kuskokwim Delta and Bristol Bay.
