THREAT LEVEL CHANGES: SEOC LEVEL 1 – ROUTINE OPERATIONS

Significant Issues: The SEOC is evaluating a request for disaster assistance from the Kenai Peninsula Borough (KPB) due to recent storm damages and power outages. DOT is also compiling response and repair costs to several roads on the Kenai Peninsula.

Shishaldin had a small explosion that produced an ash cloud. A volcano observatory notice for aviation has been released.

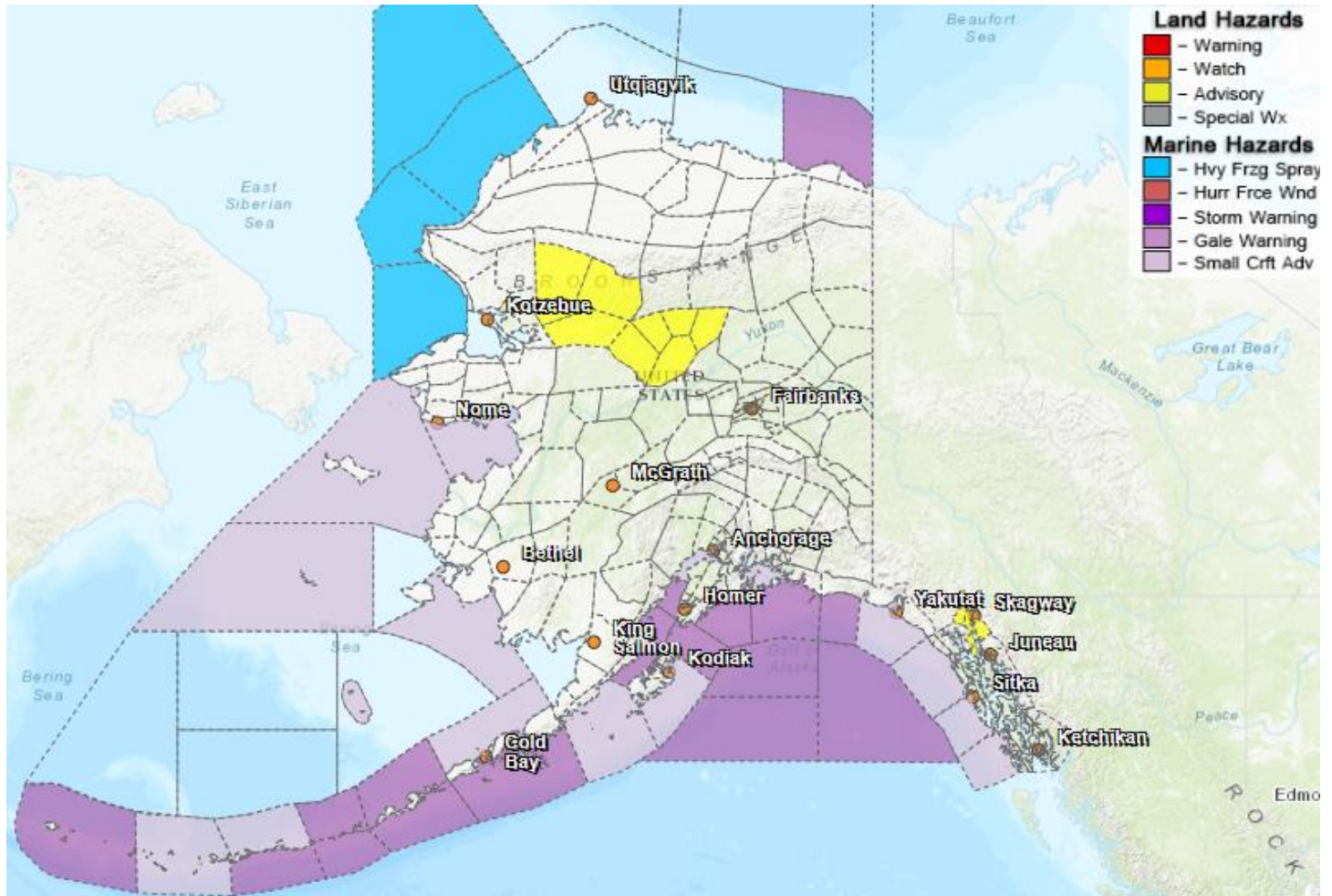
