THREAT LEVEL CHANGES: SEOC LEVEL 1 – ROUTINE OPERATIONS

<u>Significant Issues:</u> The SEOC is Continuing to evaluate a request for disaster assistance from the Kenai Peninsula Borough (KPB) due to recent storm damages and power outages. DOT is also compiling response and repair costs for damage to several roads on the Kenai Peninsula.

Over the weekend Ice Jam Flooding of Willow Creek upstream of Deneki Bridge caused several homes to be evacuated. The Red Cross sheltered three individuals last night. Contact has been established with MSB OEM. The Borough reports limited impact with 3 homes flooded and six threatened, no injuries reported and there are no requests for State assistance at this time. The SEOC continues to monitor the situation.



A Winter Storm Warning is in effect for Haines Borough and Lyn Canal, Taiya Inlet and the Klondike Highway until noon today.

A Wind Chill Advisory and Special Weather Statement for Cold Temperatures is in effect from 6pm this evening to 6 pm Tuesday for the Lower Kobuk, Upper Kobuk and Noatak Valleys, and the Southeastern Brooks Range. Expect wind chills to range from 35 below zero to 55 below zero.
