THREAT LEVEL CHANGES: SEOC LEVEL 1 – ROUTINE OPERATIONS

NTAS BULLETIN: On January 4, 2020, Acting Secretary of Homeland Security Chad F. Wolf issued a new National Terrorism Advisory System (NTAS) Bulletin pertaining to the changing threat landscape following the successful U.S.-led airstrike in Iraq that eliminated Qassem Soleimani, the head of the Iranian Revolutionary Guard Corps-Quds Force, a U.S.-designated Foreign Terrorist Organization.

Significant Issues: Last week the Alaska Native Tribal Health Consortium (ANTHC) reported that three communities: St. Michael, Noatak, and Selawik, were all experiencing water or wastewater issues due to freeze-ups from the recent extreme cold temperatures. ANTHC Rural Utility Management Services is tracking all three issues, and advising the local utilities as necessary. There are no requests for assistance at this time. ANTHC has resolved the water issue in Noatak. The SEOC will closely monitor these restoration efforts over the next few days.

The SEOC continues to monitor the response and recovery efforts underway for the flooding along Willow Creek in the Matanuska Susitna Borough (MSB).

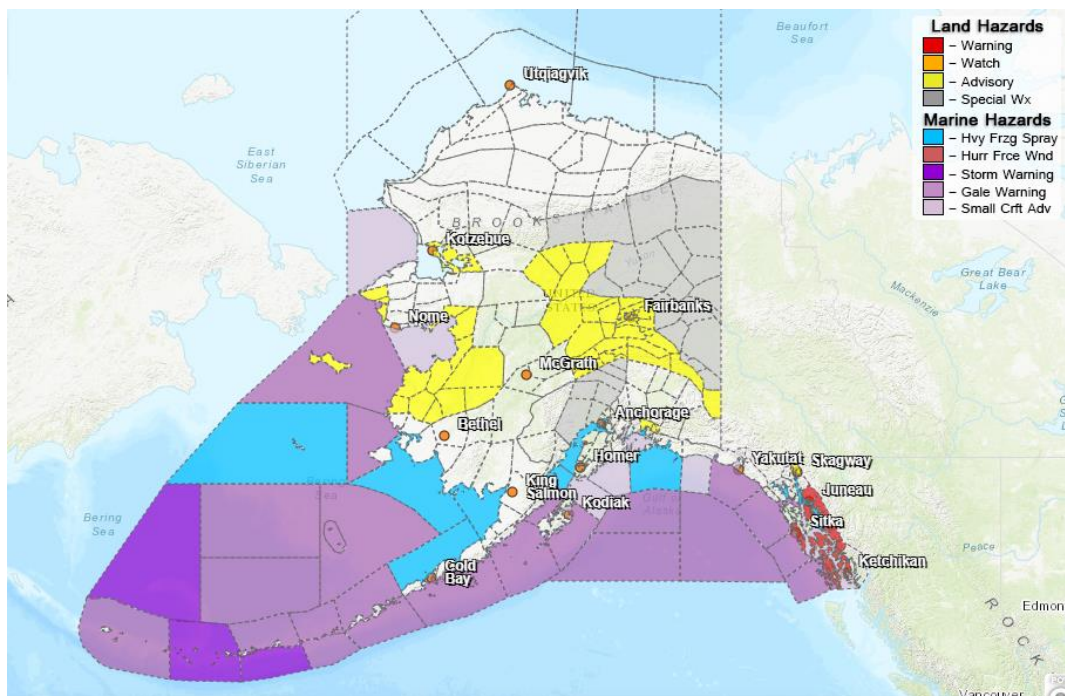
An air quality stage two alert has been issued for the Fairbanks and North Pole areas in effect until noon Friday.

Winter Storm Warning from this evening through tomorrow afternoon for the eastern Gulf coast and southern panhandle.

High Wind Warning in effect from this evening through tomorrow for the Juneau Borough and northern Admiralty Island.

Dense Fog Advisory for the Middle Tanana Valley until noon.

Wind Chill Advisories in effect for many parts of the state including the lower Yukon Valley, Bering Strait Coast, Saint Lawrence Island, Thomas Pass, central and eastern Alaska Range, and central Interior.

Flood Warning for an ice jam on the Kenai River at Big Eddy, and Hydrologic Outlook indicates continued ice dam flooding at Willow Creek.
