NTAS BULLETIN On January 4, 2020, Acting Secretary of Homeland Security Chad F. Wolf issued a new National Terrorism Advisory System (NTAS) Bulletin pertaining to the changing threat landscape following the successful U.S.-led airstrike in Iraq that eliminated Qaseem Soleimani, the head of the Iranian Revolutionary Guard Corps-Quds Force, a U.S.-designated Foreign Terrorist Organization.

Significant Issues

An earthquake with a magnitude of 6.2 and depth of 10 km struck 60 miles SW of Adak last night at 8:59 pm. The SEOC contacted the community of Adak, although the earthquake was felt, there are no reports of damages. The SEOC will continue to monitor the situation.



Significant Weather:



A Wind Chill Advisory is in effect from 9:00 pm this evening to noon AKST Saturday with wind chills as low as 40 below zero Bristol Bay including the cities of King Salmon, Dillingham, Naknek, and Pilot point Mekoryuk and Toksook Bay to Illiamna North and down to Port Heiden. The Kuskokwim Delta including the cities of Bethel, Hopper Bay, and Nunivak Island.

A Winter Storm Warning remains in effect for Taiya Inlet and Klondike Highway-Haines Borough and Lynn Canal- Including the cities of Skagway and Haines. Until 6:00 pm Friday night.

A special weather statement is in effect regarding another round of cold temperatures for the Central Interior, Deltana and Tanana Flats, Eastern Alaska Range, Middle Tanana Valley, Southeastern

Brooks Range, Upper Koyukuk Valley, Upper Tanana Valley and the Fortymile Country, and the Yukon Flats and Surrounding Uplands. Temperatures along the AlCan Border are expected to fall to around 50 below, while temperatures in the Middle Tanana Valley will fall into the 30s below Sunday and Monday before starting to warm. High temperatures will only be 5 to 10 degrees warmer than the lows. Residents should prepare for the cold, especially if traveling, by keeping cold weather gear available at all times.
