Significant Issues

On January 29, 2020 the community of Newhalen, in the Lake and Peninsula Borough, reported flood waters rising near several homes and the sewage lagoon as a result of ice jam overflow from the Newhalen River. SEOC coordinated technical assistance from the National Weather Service and US Army Corps of Engineers. On Saturday, February 1, 2020 the Lake and Peninsula Borough Assembly passed a resolution declaring a local disaster emergency for the Newhalen River overflow flooding and requested State disaster assistance. SEOC will continue to monitor the situation, assess the needs of the community, and coordinate as needed.



A Winter Storm Warning is in effect until Tuesday for St. Lawrence Island and the Bering Strait Coast, Eastern Norton Sound and Nulato Hills, Upper and Lower Koyukuk Valley, Yukon Delta, Yukon Valley, and the Central Interior.

A Winter Storm Warning is in effect until Tuesday for the Haines Borough and Lynn Canal, Eastern Chichagof Island; Glacier Bay; Juneau Borough and Northern Admiralty Island.

Winter Weather Advisories are in effect for the remainder of the Panhandle and the Eastern Alaska Range.
