Significant Issues

The SEOC was contacted by the North Slope Borough (NSB) Friday morning regarding the loss of the school in Kaktovik overnight. There were no injuries or deaths due to the fire. The SEOC reached out to several state agencies for their input. The North Slope Borough declared a local emergency requesting assistance in the form of technical and financial assistance from the State. The SEOC is collecting information and will continue to be in contact with the North Slope Borough in regards to these requests and will continue to monitor the situation.



Wind Chill Advisories are in effect for the Eastern Norton Sound and Nulato Hills until 12:00pm Monday.

Winter Weather Advisories are in effect for the Northeastern Brooks Range, Central Beaufort Sea Coast and the Eastern Alaskan Range until 6:00am Tuesday.

Winter Storm Warnings are in effect for the Taiya Inlet and Klondike Highway until 9:00pm Monday

A Special Weather Statement has been issued for the Central Western Coast, Interior, and Central Eastern portions of the state for a return of cold temperatures. Temperatures are expected to be between -20 to -40 degrees.
