

Significant Weather:



A High Wind Warning is in effect until this evening for the eastern Alaska Range.

A Winter Storm Warning is in effect beginning this evening for the Haines Borough and Lynn Canal, Taiya Inlet and Klondike Highway.

Blizzard Warnings are in effect until noon today for Thompson Pass and for Saint Lawrence Island and the Bering Strait Coast.

A Winter Storm Warning is in effect until tomorrow morning for the Upper Kobuk and Noatak Valleys, and for the Lower Koyukuk and Middle Yukon Valleys.

Winter Weather Advisories are in effect for much of Southcentral, the Eastern Interior, Western Arctic Coast, and Northwest Interior/Coast.

Avalanche

Cordova: Considerable above 2,000 feet, Moderate above 1,000 feet.

Valdez: Moderate at all elevations.

Turnagain Pass: A Backcountry Avalanche Warning is in effect with HIGH avalanche danger; travel is not recommended.
