DHSS is closely monitoring the rapidly-emerging outbreak of novel coronavirus (COVID-19).



A Blizzard Warning is in effect until noon Thursday for Thompson Pass.

A Blizzard Warning is in effect from this evening until Thursday morning for Skagway and the Klondike Highway.

A Winter Storm Warning is in effect for the southeast coast for heavy snow from Yakutat to Juneau until tomorrow morning.

A High Wind Warning is in effect until Thursday afternoon for Valdez.

A Wind Chill Warning is in effect until this afternoon for the Central and Eastern Beaufort Sea Coast.

Wind Chill Advisories are in effect for the Northern Susitna Valley, Eastern Alaska Range, and Southeastern Brooks Range.
