

#### Significant Weather:



A high wind warning is in effect from 7 PM this evening through 6 AM wednesday for Dixon Entrance to Cape Decision Coastal Area and the Southern Inner Channels.

A flood watch is in effect through Wednesday morning for the Salcha River near the bridge.

A flood advisory for rain and snowmelt flooding is in effect near Ward Lake in the Southern Inner Channels.

A special weather statement has been issued for localized flooding across the interior. Rapid snow melt last week is causing minor flooding of numerous low lying areas across Interior Alaska. Many creeks, sloughs and rivers are high, with water running on top of the ice and some ice jams. Areas that currently have minor flooding will likely have high water remaining for a few more days. Cooler night time temperatures across the Interior have slowed down the snow melt, and some locations are seeing water levels falling slowly. Cooler than average temperatures are expected to persist this week before again increasing this weekend.
