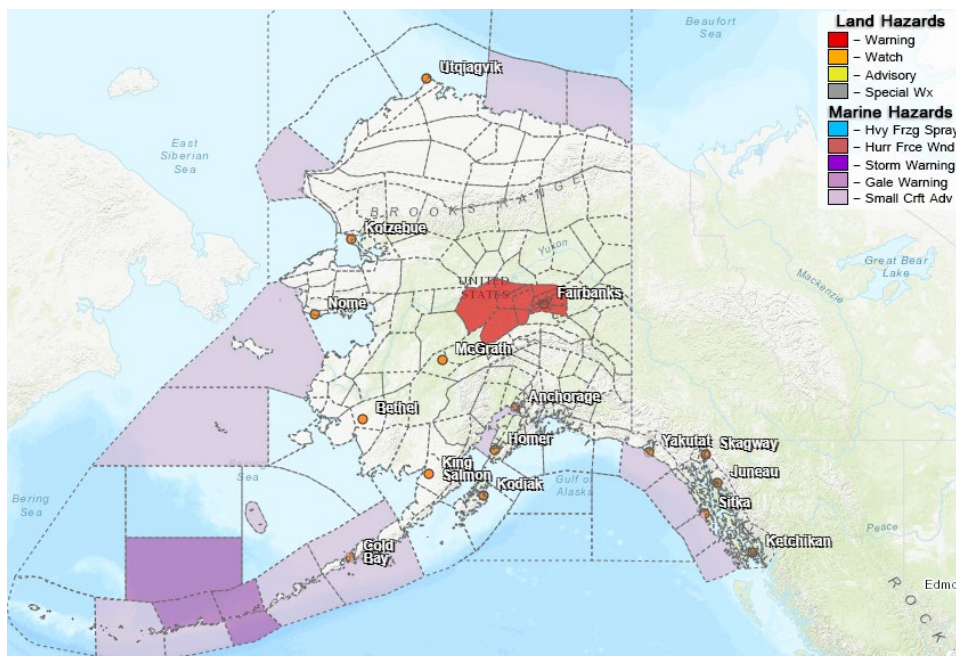

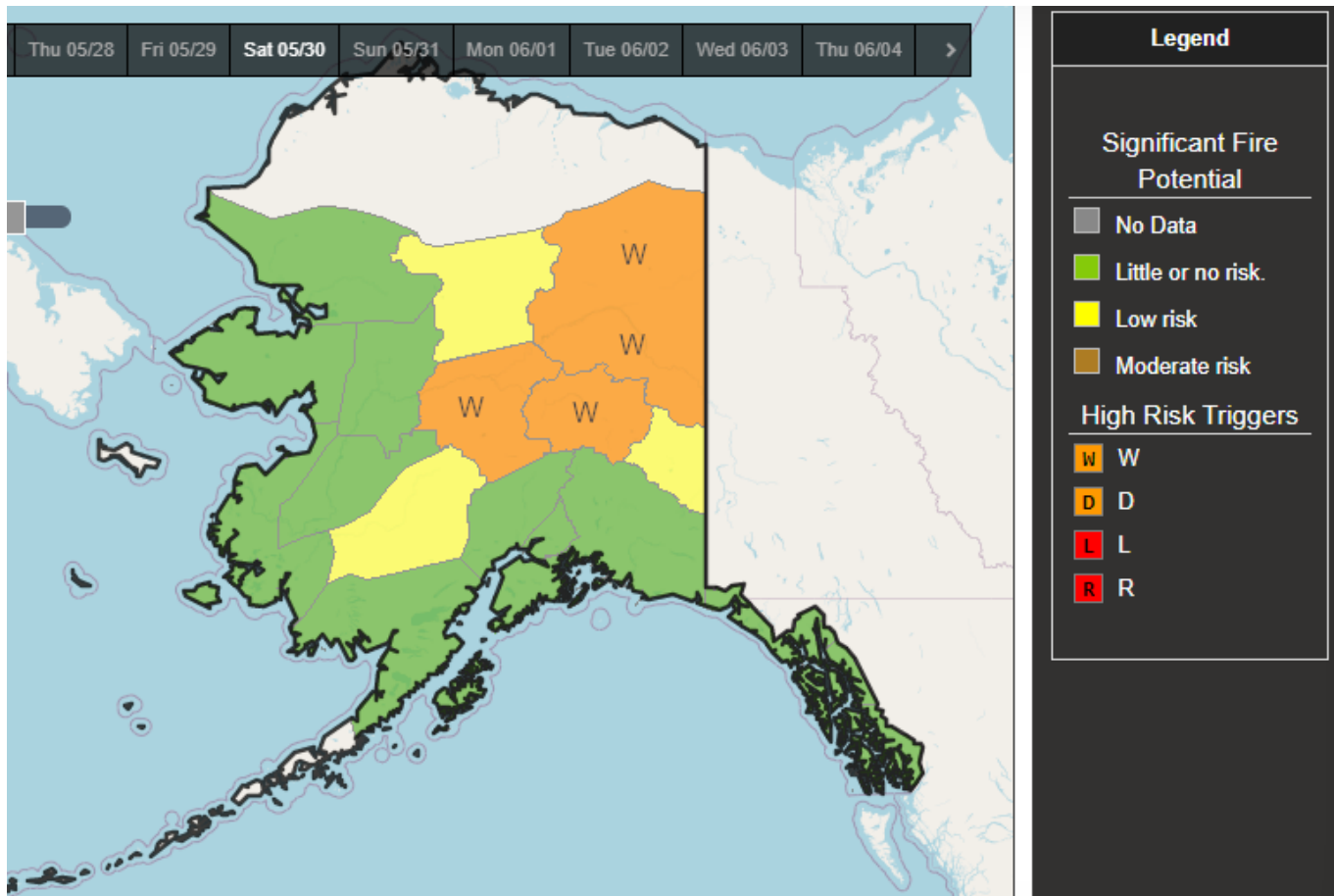
Significant Weather:
