Coronavirus (COVID-19) Pandemic

A unified command has been established at the SEOC. The SEOC Preparedness Level remains at Level 3 for this event.

2020 Fire Season

The Alaska Interagency Coordination Center, (AICC) is at Preparedness Level 3.

Wildland fire totals for 2020:

- Total Fires = 246
- Total Acres = 146,167

There are currently 122 active fires with 8 fires currently staffed.

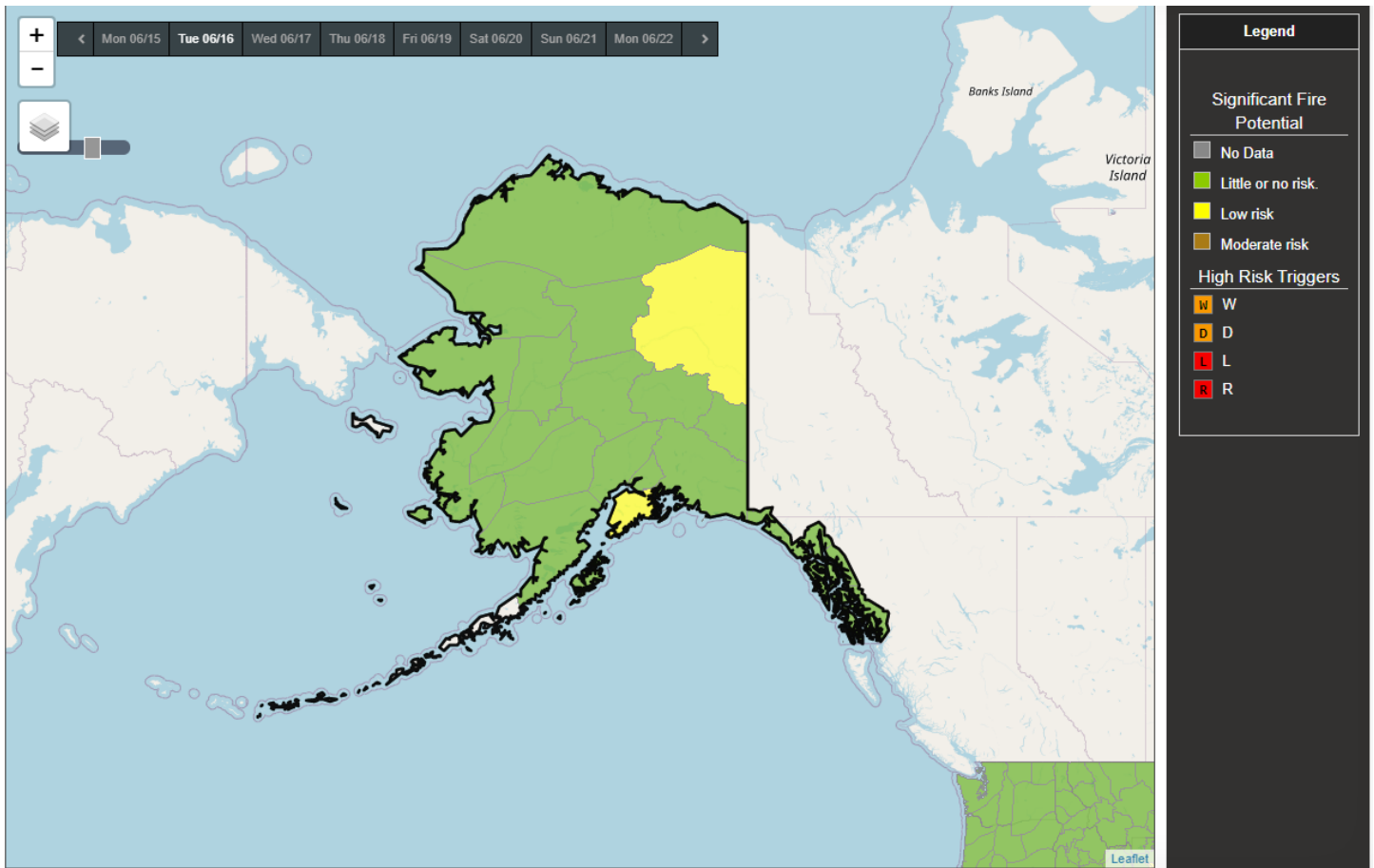
