Significant Issues

Chignik 7.8 Earthquake

DOT&PF engineers have completed their inspection of facilities impacted by the M7.8 earthquake last month, and, this report has been forwarded to the Lake and Peninsula Borough, Aleutians East Borough, and the cities of Sand Point and Cold Bay, for their review. The cities and boroughs are evaluating the report's findings and recommendations, and will determine if they need to declare local disasters with requests for State disaster assistance for this earthquake.

Delta River Flooding

DOT&PF has completed preliminary repairs that have stopped the active flooding. An inspector with the Natural Resources Conservation Service conducted an assessment of the Spengler Road/Delta River site on Wednesday morning to determine eligibility for the NRCS Emergency Watershed Protection Program. NRCS will complete their evaluation and provide the DOT&PF a report on the eligibility and likelihood of federal funding for erosion control and/or watershed protection for the area.

The SEOC continues to coordinate with DOT&PF and our federal agency partners to develop a plan for a long-term solution.

Coronavirus (COVID-19) Pandemic

A unified command has been established at the SEOC. The SEOC Preparedness Level remains at Level 3 for this event.

2020 Fire Season

The Alaska Interagency Coordination Center, (AICC) is at Preparedness Level 1.

Wildland fire totals for 2020:

Total Fires = 322

Total Acres = 181,678

There are currently 21 active fires with 0 fires currently staffed.


