Yesterday afternoon the Aleutians East Borough sent the SEOC a signed Disaster Declaration for the July 21 M7.8 earthquake. The SEOC will continue to communicate with the Aleutians East Borough in support of their declaration and response efforts.

Coronavirus (COVID-19) Pandemic

A unified command has been established at the SEOC. The SEOC Preparedness Level remains at Level 3 for this event.

2020 Fire Season

The Alaska Interagency Coordination Center, (AICC) is at Preparedness Level 1.

Wildland fire totals for 2020:

Total Fires = 331

Total Acres = 181,213

There are currently **13** active fires with 0 fires currently staffed.

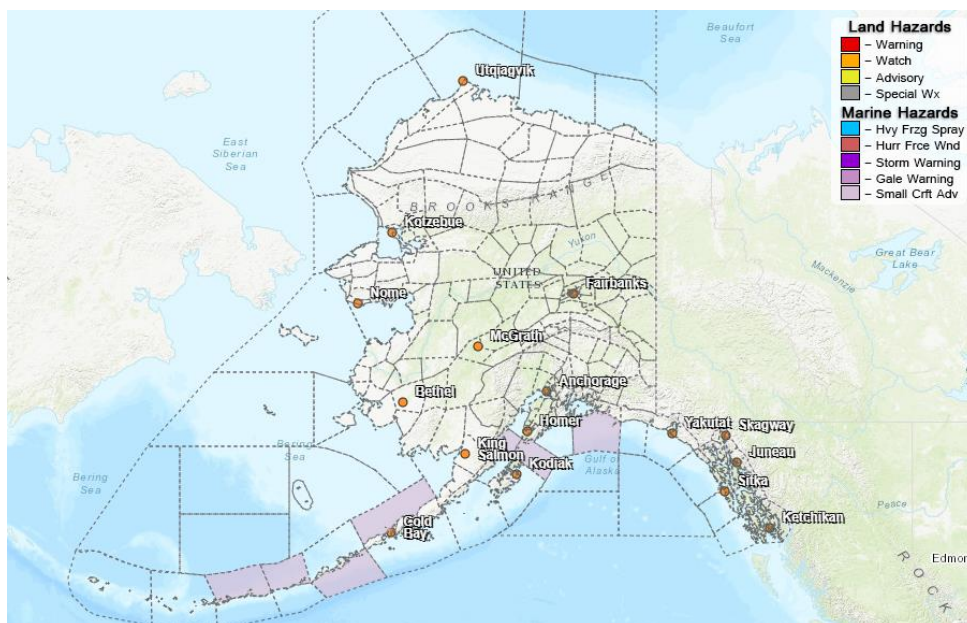
