

A Flood Watch is in effect through this afternoon for rivers and streams which drain the Talkeetna Mountains in the Matanuska Valley and Susitna Valley.

A Special Weather Statement has been issued for rising water on the Nelchina River, Tazlina Lake, and Tazlina River, due to a release from a glacier dammed lake on the Nelchina Glacier.
