

Significant Weather:



Special weather statement in effect for strong winds along the Turnagain Arm and gusty conditions across the remainder of the Anchorage area and the Mat-Su Valley today. Sustained winds of 45 to 60 mph with gusts to 70 mph are expected in the higher elevations in the area.

Special weather statement in effect for the Seward and Western Susitna Valley area. 2 inches of rain fall throughout the day has the potential to raise the water levels in the Resurrection River and other surrounding rivers and streams.

High wind advisory in effect until Friday morning at 6:00 am (09/18) for Denali and the Eastern Alaska Range, as well as the Delta Junction Area. Potential for sustained winds of 50 mph with gusts to 65mph
