Significant Issues:

Tuluksak Washeteria Fire:

The SEOC continues to evaluate the potential needs of the community of Tuluksak following the loss of their washeteria on January 16. The Alaska State Troopers, DEC, and the Yukon Kuskokwim Health Corporation are all involved in assisting the community. Currently, work is being done to run water from the well that served the washeteria, to the school to develop a temporary water supply. Until that time, the community is using bottled water. The village store and clinic have a limited supply of bottled water on hand, with more scheduled to arrive this week. There are also three pallets of bottled water in Anchorage awaiting shipment. The Tuluksak Council is considering a local declaration of disaster emergency and will discuss this measure at their meeting today.

SEOC remains in active contact with the community and responding agencies to coordinate response assistance and recovery.

Coronavirus (COVID-19) Pandemic:

A unified command has been established at the SEOC. The SEOC continues to support statewide response to COVID-19.

State of Alaska Department of Health and Social Services (DHSS)

DHSS is operating as the Medical Branch under the State EOC/Unified Command.



Significant Weather:



A Winter Storm Warning is in effect for the following areas:

- Yukon Delta until noon tomorrow. Heavy blowing snow with winds gusting to 45 mph.
 Total snow accumulations of 4 to 6 inches are expected with freezing rain possible on Thursday.
- St. Lawrence Island & Bering Strait Coast until midnight tomorrow. Heavy blowing snow with winds gusting to 55 mph. Total snow accumulations of 4 to 8 inches with localized amounts of up to 10 inches are expected.
- Baldwin Peninsula, Selawik Valley, & the Chukchi Sea Coast until 3:00 A.M. Friday. Total snow accumulations of 2 to 5 inches with winds gusting to 50 mph.
- Southern Seward Peninsula Coast, Eastern Norton Sound & Nulato Hills until 9:00
 A.M. Friday. Total snow accumulations of 2 to 5 inches, with localized amounts of up to 8 inches are expected with freezing rain possible Thursday.
- Lower & Middle Yukon Valleys, Lower Kooyukuk Valley, Lower Kobuk & Noatak Valleys until 6:00 P.M Friday. Total snow accumulations of up to 4 to 6 inches with localized amounts of up to 10 inches are expected with winds gusting to 45 mph.

A Winter Storm Watch is in effect for the Western Arctic Coast until 6:00 A.M. Friday. Total snow accumulations of up to one inch are possible with winds gusting to 40 mph.

A Winter Weather Advisory is in effect for the Northern & Interior Seward Peninsula until 8:00 P.M. Thursday. Total snow accumulations of 1 to 3 inches are possible with winds gusting to 40 mph.

A Wind Advisory is in effect for the Eastern Alaska Range until 3:00 P.M. Friday. Southwest winds 25 to 35 mph with gusts to 50 mph are expected.
