#### Significant Issues:

#### 2020 December Southeast Storm Disaster:

A Joint State/FEMA Preliminary Damage Assessment continued this week for the declared area and will conclude on Monday.

To date, the state has received 104 registrations for State Individual Assistance. Damage verification teams will deploy to the declared area on Monday, January 25. The teams will travel to Juneau, Haines, Skagway, and other Southeast communities to assess residential property damages.

#### **Tuluksak Washeteria Fire:**

Yesterday, the SEOC received a signed disaster declaration from the Tuluksak Native Community regarding the loss of their washeteria due to fire. The community has established a temporary non-potable water source in the river and has been provided bottled water for drinking. There are several regional health organizations and state and federal agencies working to help the community with immediate and long-term needs.

#### Coronavirus (COVID-19) Pandemic:

A unified command has been established at the SEOC. The SEOC continues to support statewide response to COVID-19.

#### State of Alaska Department of Health and Social Services (DHSS)

DHSS is operating as the Medical Branch under the State EOC/Unified Command.


#### Air Quality Index (AQI) Advisories

#### Significant Weather:



Winter Storm Warnings and Winter Weather Advisories remain in effect today for much of western Alaska, including the middle and lower Yukon River, Koyukuk, Seward Peninsula, and Kotzebue Sound.

A Winter Weather Advisory for wind and blowing snow remains in effect through this afternoon for the Northern Arctic Coast, and the Central and Eastern Beaufort Sea Coast.

A Wind Advisory is in effect for Denali and the Eastern Alaska Range until Saturday morning.
