#### Significant Issues:

#### **Selawik Power Outage:**

On Monday February 15, the Northwest Arctic Borough contacted the SEOC reporting a power outage in the community of Selawik. The Alaska Village Electric Cooperative was actively engaged in repairs and power was restored to a portion of the community. One of the communities three generators is working, but they are still rationing power and using scheduled outages. The area of town that continues without power has approximately 150 residences, a 20-unit apartment complex, the school, and water treatment plant. The water treatment plant is now on backup power. A few families without a secondary residential heat source were sheltered in the school overnight. The SEOC is in regular contact with the Borough and Selawik Tribal Administrator. The City declared a local disaster yesterday afternoon.

#### **Tuluksak Water System Fire:**

Remote water maintenance workers, contractors, and the Yukon Kuskokwim Health Corporation have laid pipe to the Tuluksak River and expect to insert a pump today. The team anticipates pumping water tomorrow and to have water for the school system this week. Next week they intend to begin thawing the water transmission line. Once operational, this temporary water system will provide non-potable water for a laundry facility, and hopefully the fire suppression systems for the school. SEOC is in regular contact with community leadership to address any immediate needs

#### Coronavirus (COVID-19) Pandemic:

A unified command has been established at the SEOC. The SEOC continues to support statewide response to COVID-19.

#### State of Alaska Department of Health and Social Services (DHSS)

DHSS is operating as the Medical Branch under the State EOC/Unified Command.



Wind Chill Advisories and Warnings are in effect for the Northern and Western Arctic Coasts and the Central and Eastern Beaufort Sea Coasts until noon on Friday.

A Winter Weather Advisory is in effect for the Eastern Alaska Range until 3:00 P.M. tomorrow.

A Special Weather Statement is in effect for Anchorage, MatSu and Susitna Valleys and the Western Kenai Peninsula. 2 to 4 inches of snow is expected late Wednesday night into Thursday, with localized amounts of up to 8 inches.

A Special Weather Statement has been issued for the Central, Eastern and Western Interior. Light snow is expected across the region through Thursday.
