Selawik Power Outage:

Full electrical power is available in the community and power conservation measures are no longer needed. Potable water is available in the community. Some water and sewer mains and individual service lines remain frozen. The SEOC is in regular contact with community leadership to address any immediate needs.

Unalakleet Water Issues:

The SEOC has demobilized the Division Supervisor for Unalakleet. The SEOC continues to support the response and recovery efforts that are underway for the community. The SEOC is in regular contact with community leadership to address any immediate needs.

Coronavirus (COVID-19) Pandemic:

A unified command has been established at the SEOC. The SEOC continues to support statewide response to COVID-19.

DHSS is operating as the Medical Branch under the State EOC/Unified Command.

The National Weather Service has issued a Special Weather Statement for trace amounts of ashfall possible in the vicinity of Veniamof.



Significant Weather:



Blizzard Warnings are in effect for much of the West Coast, including Saint Lawrence Island, Bering Strait, Norton Sound, Yukon Delta, Chukchi Sea Coast, Kobuk and Noatak Valleys, and nearby areas until this evening as a powerful winter storm impacts the region. Heavy snow and high winds are expected. Travel will be very difficult. Visibility will be near zero at times.

Winter Storm Warnings and Winter Weather Advisories are in effect for many areas adjacent to the areas with blizzard conditions, including Bristol Bay, the Kuskokwim Delta, Alaska Peninsula, Arctic Coast, and adjacent uplands. Winter Weather Advisories are also in effect for the Brooks Range and Beaufort Sea Coast as the storm progresses northeastward through Tuesday morning.

A Wind Advisory is in effect for the Eastern Alaska Range until Tuesday morning.
