## **Buckland Flooding:**

Governor Dunleavy verbally declared a disaster yesterday for Buckland including Individual Assistance and Public Assistance. The SEOC has begun operational planning to deploy a Damage Assessment team to Buckland this week. The SEOC is coordinating concurrent damage assessment activities by the DEC and voluntary agencies. The SEOC continues to participate in response coordination meetings with the Northwest Arctic Borough (NWAB), Buckland City, Buckland Tribe, and Buckland School. The City of Buckland reports community water production and distribution, and electrical systems are continuing to function and the DEC lifted the boil water notice for the community.

#### **River Watch:**

All River Watch teams have been demobilized. The 2021 River Watch program has been completed. According to the NWS, the Yukon River is mostly open except for some ice in place downstream from Emmonak and Alakanuk. The Porcupine River is partly to mostly open upstream from Ft. Yukon to the US/Canada border. Snowmelt is just beginning on the Porcupine with higher water expected at Ft. Yukon over the next two weeks. The risk from ice jam flooding is low. Communities can still expect light runs of ice as the river rises and lifts stranded ice from the river banks.




