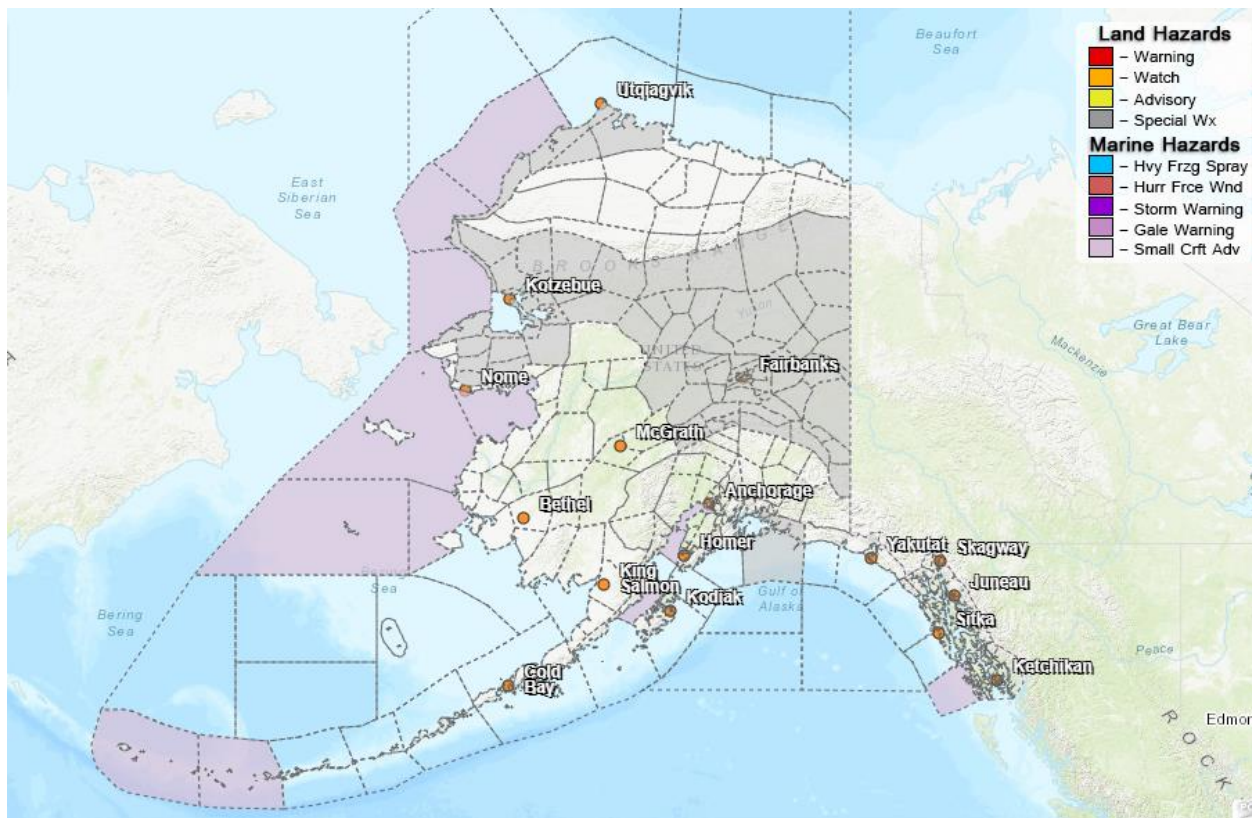

Significant Weather:



A Special Weather Statement has been issued for elevated surf levels along the Chukchi and Arctic Sea coasts from Shishmaref to Utqiagvik. Water levels one to two feet above the normal high tide line are expected.

A Special Weather Statement has been issued for much of the interior. Snow accumulation of up to 4 inches is expected across the region at elevations above 2000 feet for the next two days.

A Special Weather Statement remains in effect for the Berg Glacier dammed lake east of Cordova. The lake is releasing water into the Gandil River. High water from this release usually lasts for several days and causes flooding between Bering and Starodubtsov Lakes. Debris is also expected in the Controller Bay area as a result of this release.
