

Significant Weather:



A Winter Storm Warning for heavy snowfall has been issued for the Southeastern Brooks Range, Central Interior, Koyukuk, Kobuk, Noatak and Middle Yukon Valleys from noon tomorrow through Thursday night.

A Winter Weather Advisory for snowfall has been issued for the Susitna Valley north of Talkeetna from Tuesday night through Thursday morning.

A Special Weather Statement has been issued for the Western Kenai Peninsula. The Skilak Glacier dammed lake began releasing over the weekend, resulting in elevated water levels on Skilak Lake and the Kenai River. The water is expected to crest around bank full by tomorrow.

A Special Weather Statement has been issued for much of the western coast of Alaska. A strong storm system in the Bering Sea is expected to impact the area late Monday into Tuesday. High winds and elevated surf levels are expected along south and west facing coastlines.
