**Significant Issues:**

The SEOC was contacted by the emergency preparedness coordinator in Nome yesterday. He reported several residents of Teller had called in reports of significant food security issues. The SEOC is working with the community to identify what is causing the issue and to determine how to address it.

The SEOC continues to work with the Mat-Su Borough and the City of Houston on their disaster declaration regarding multiple locations with flooding that impacted roads and homes in the Houston area.

The SEOC continues to work with the Municipality of Skagway on the ongoing landside issue, their disaster declaration and request for state assistance.

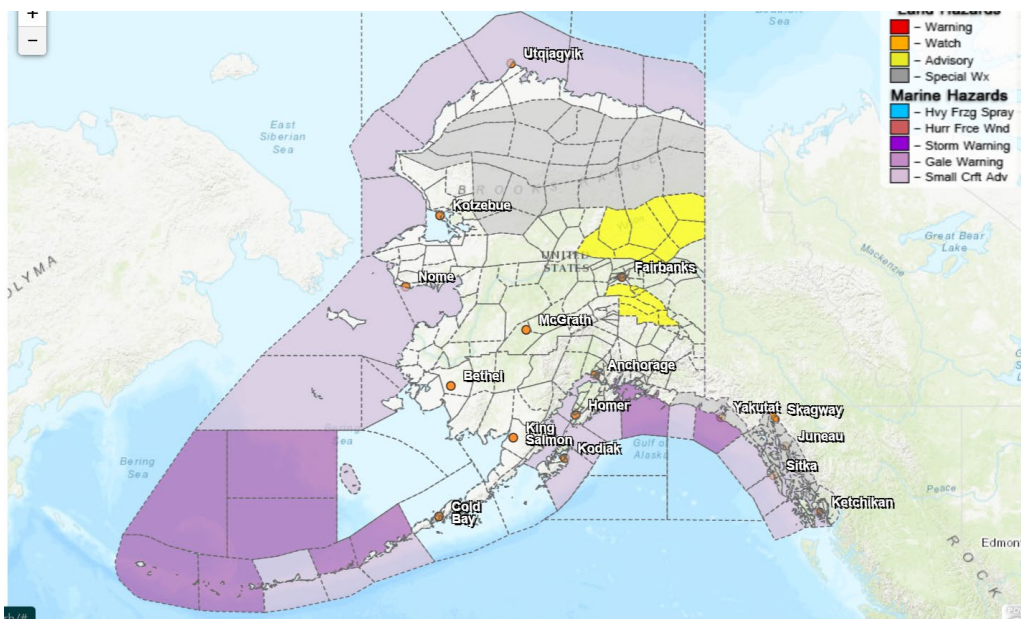

## Significant Weather:



Wind Advisory issued for Yukon Flats and Surrounding uplands. Southwest winds up to 45 mph expected through Thursday at 6:00PM

Wind Advisory issued for Deltana and Tanana Flats. South winds up to 50 mph expected from 11:00AM Wednesday to 1:00AM Thursday.

Wind Advisory issued for Eastern Alaska Range. South winds 35 – 45 mph with gusts up to 60 mph expected from 7:00 AM Wednesday to 10:00AM Thursday.

**Flood Watch has been issued for Taiya River including the City of Dyea and Skagway, as well as the Klondike Highway. Excessive rain fall flooding is expected. Watch is in effect until Wednesday evening.**

Special Weather statement has been issued for heavy rain covering most of South East Panhandle. 3+ inches is expected through Wednesday evening.
