

#### The following Warnings, Watches, and/or Advisories have been issued:

#### Flood watch:

 Central Interior along the Tanana River from Old Minto to Manley Hot Springs until Wednesday afternoon for flooding caused by excessive rainfall.

#### Flood Advisory:

• Middle Tanana Valley; Deltana and Tanana Flats – in effect until noon AKDT Saturday.

#### **High Surf Advisory:**

- Yukon delta in effect from 1pm this afternoon until 6amThursday for winds gusting to 40mph causing high surf conditions.
- St. Lawrence Island and Bering Strait Coast in effect starting at 6pm this evening until 6am Thursday for winds gusting to 40mph causing high surf conditions.
- Northern and Interior Seward Peninsula, Chukchi Sea Coast, Baldwin Peninsula and Selawik Valley in effect from 6am Wednesday until 6am Thursday for winds gusting to 40mph causing high surf conditions.

#### Wind Advisory:

• Denali, Eastern Alaska Range – in effect from noon today until 6am Wednesday for winds of 25 to 40mph with gusts up to 60mph.
