**Significant Issues:**

**Multiple Alaska School District Bomb Threat**

Yesterday, the SEOC was notified from the Executive Director for Superintendents of an email they received of a bomb threat to multiple school districts across the state and participated in multiple interagency coordination calls to ensure the proper authorities were notified and correct actions were identified and given to the respected school districts.

All involved agencies were made aware to contact the SEOC if conditions change or if they had any questions regarding additional actions to take.

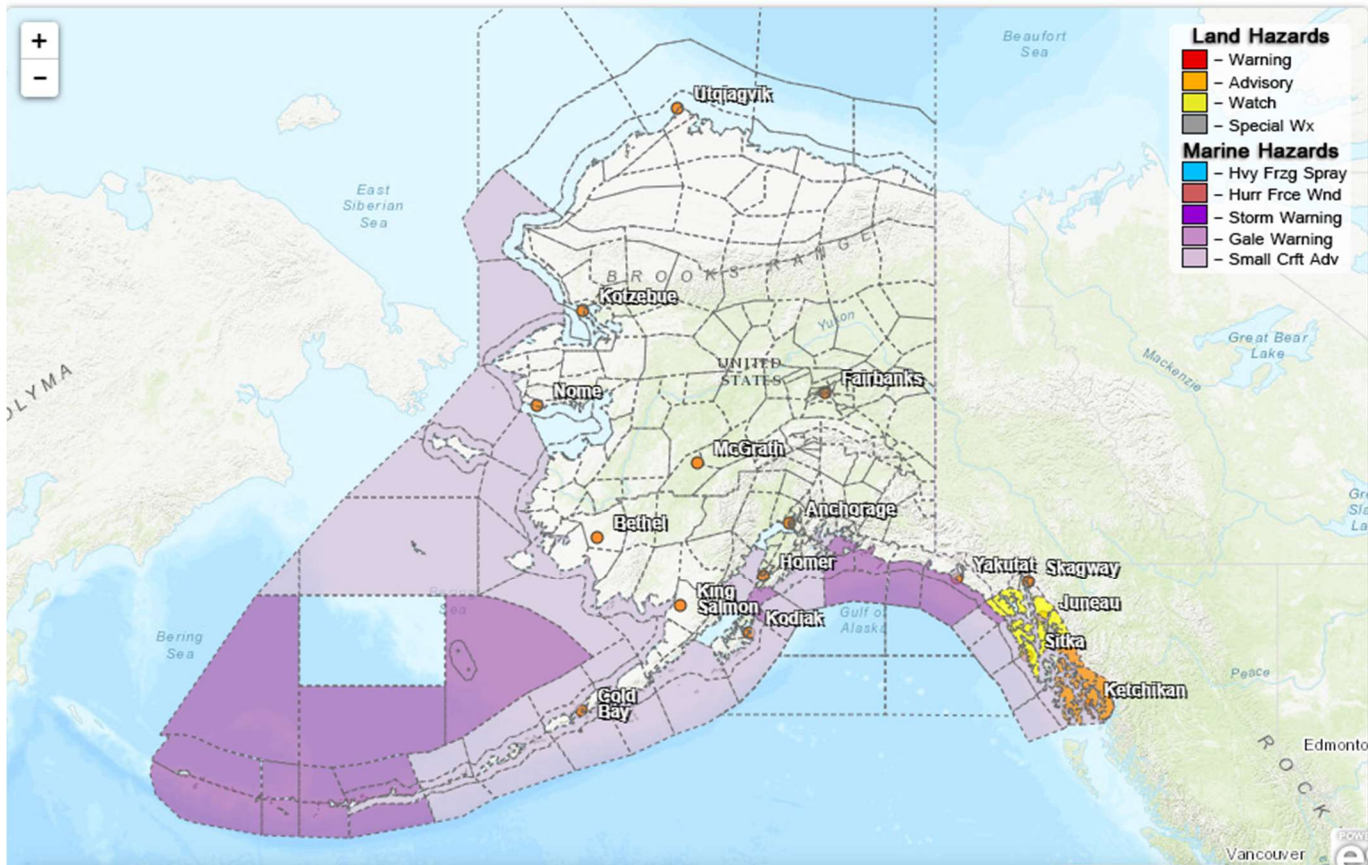

- Northern Arctic Coast; Central Beaufort Sea Coast; Eastern Beaufort Sea Coast – elevated surf from Utqiagvik east tonight into Friday morning.

### Dense Fog Advisory:
