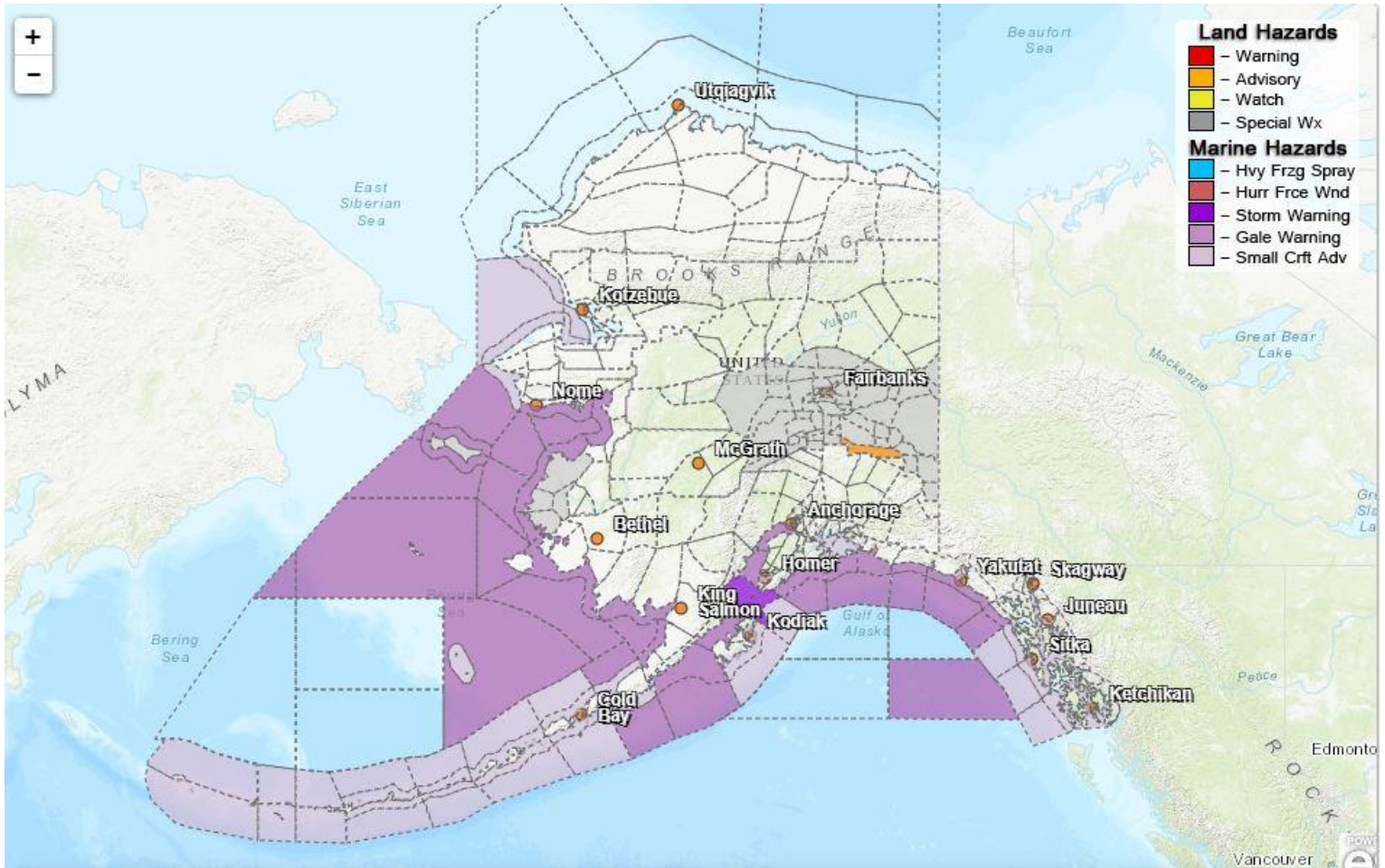

### Special Weather Statement

Elevated surf is expected along the coast near the Yukon Delta and St Lawrence Island. Winds will increase Thursday morning into Saturday with wind speeds of 30 to 45 mph with gusts up to 60 mph.

Winter weather advisory remains in effect for the Eastern Alaska Range until noon Friday for snow accumulation up to 6 inches and winds gusting to 25mph.
