# Significant Issues:

## Wrangell Landside Disaster:

State Individual Assistance application hotline and website is open for Wrangell and Prince of Wales Island residents at <a href="https://www.ready.alaska.gov/Recovery/IA">https://www.ready.alaska.gov/Recovery/IA</a> or by phone 1(844) 445-7131. The deadline to apply for State Individual Assistance is January 27, 2024.

#### **Point Hope Power Outage:**

Water plant technicians have restored water and sewer to twenty homes, with another 83 still needing service. Damage assessment is still ongoing as thawing out continues.

#### Savoonga Power Outage:

Alaska Village Electric Cooperative technicians restored power to community infrastructure, and all homes have been fully restored. SEOC Mass Care Group engaged for support and feeding.

#### Quinhagak Power Outage:

Local operators continue to repair the power system, transformers, and utility lines within the Village of Quinhagak. SEOC has been fully engaged with a multiagency response to manage state declared disaster needs.

#### **Manokotak Generators:**

Parts have been ordered for generators and are expected to arrive next week. An emergency backup generator has been resourced from Naknek, and the SEOC is engaged with the National Guard to assess transport options.

# 6.1 Magnitude Earthquake near Atka Pass:

At 5:55 AKST, a 6.1m earthquake occurred 53 miles south of Atka Pass and 72 miles southeast from Adak. SEOC contacted the Alaska Earthquake Center, which did not identify any danger to communities. The city of Adak was also contacted, and even though the community felt the earthquake, damage assessment was delayed until first light.

Special Weather Statements in effect for:


