Significant Issues:

Severed Offshore Internet Cable – Utqiagvik

Full impact of the fiber optic line outage on the North Slope is still being assessed. Communications in the impact area are degraded to an estimated 20% of normal, with voice traffic being prioritized over data. SEOC participated in coordination calls with the State Office of Technology, North Slope Borough, Inupiat Community of Arctic Slope, and Alaska Department of Health Emergency Management, to consider options for providing service during the outage.

AMBER Alert – Fairbanks

Yesterday, the Alaska State Troopers issued an AMBER Alert for an abducted 2-year-old from Fairbanks with suspect information and suspect vehicle description. SEOC supported the alert dissemination. The Alert was canceled twenty minutes later when the child was recovered safe, and suspect taken into custody.

Dalton Highway Flooding

Sagavanirktok River flooding continues to challenge Dalton Highway operations, with Alaska Department of Transportation and Public Facilities actively responding to keep one lane of the Highway open.

2023 Spring Floods Disaster:

Recovery work continues for communities flooded through active Mass Care response, State Disaster Individual Assistance (IA) and Public Assistance programs. Red Cross has 102 disaster assistance applicants and State of Alaska has received 159 IA applications. Preliminary Damage Assessments are ongoing.

- High Surf Advisory Flood in effect for the Southern Seward Peninsula Coast until 4 AM AKDT Thursday.
- High Surf Advisory Flood in effect for the St. Lawrence Island and Bering Strait Coast until 4
 AM AKDT Thursday.
- Flood Warning in effect for Central Beaufort Sea Coast Flood waters are eroding the Dalton Highway between Milepost 401 and 407, with the road down to one lane. If conditions worsen, the road may wash out and become impassible. The Dalton Highway from mileposts 401 to 407. These conditions are expected to persist until ice in the main channel clears. Elevated flows are expected to continue, especially with rainfall expected late this week. Rain and snowmelt in the Brooks Range will cause the Sagavanirktok River to continue to slowly rise through Thursday @ 6 PM AKDT. Travelers are urged to call 511 or visit 511.alaska.gov for the latest on road conditions in the area.
