Significant Issues:

2023 Spring Floods Disaster

Red Cross has completed their Disaster Registration with 102 total applicants. Alaska Department of Transportation and Public Facilities is actively working on flood impacted roadways in multiple areas including the Dalton, Elliot and Steese Highways. SEOC is preparing for joint Preliminary Damage Assessments with the Federal Emergency Management Agency. To date the state has received 191 total disaster Individual Assistance registrations. Deadline for Registration is July 23, 2023.


