## Alaska Wildland 2023 Fire Season:

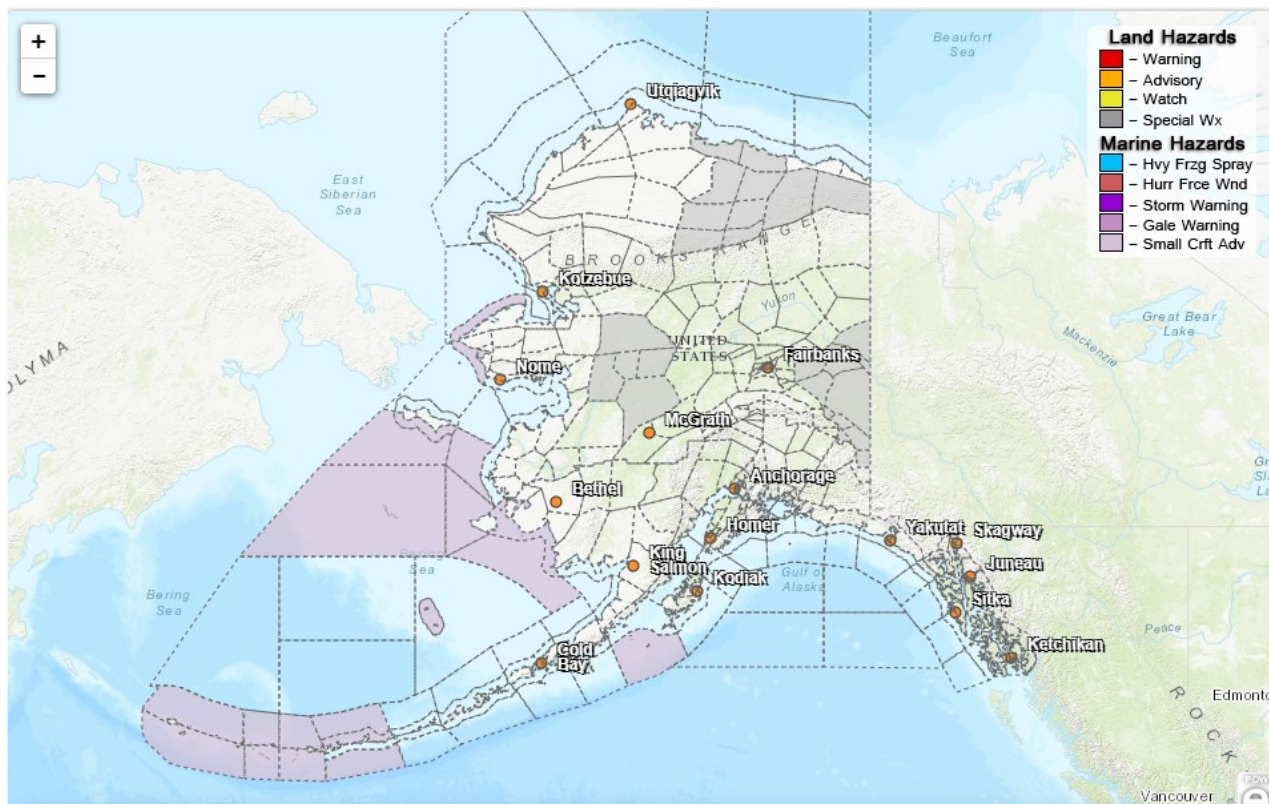

- Special Weather Statement in effect for Central Beaufort Sea Coast; Northern Brooks Range – Heavy rainfall and rising river levels again this week. Larger rivers such as the Colville, Kuparuk and Sag will rise back to near bank full Thursday and Friday. No river flooding is expected, but people along rivers in this area should be alerted to rising water levels.
